REMARKS BY ELECTED AND APPOINTED OFFICIALS AND OTHER DIGNITARIES.

Ms. Ciesla acknowledged our dignitaries present, County Clerk Holly Mackey, Prosecutor James Pfeiffer, Surrogate Michael J. Doherty, Senator Douglas J. Steinhardt, Congressman-Elect Thomas Kean, Jr. and Honorable Judge Kevin Shanahan. Commissioner Director Ciesla thanked all for coming today.

Ms. Ciesla acknowledged the Department/Division Heads and thanked them for all that they do for our county and as well as attending the reorganization meeting. Department/Division Heads in attendance are as follows: Calvin Inscho, Ken McCarthy, Bill Duffy, Bob Sidie, Corey Tierney, Scott Burd, Art Charlton, Emily Hammer, Marie Watters, Melissa Pritchett, Kim Francisco, Dennis Riley, Tom Nigro, Lauren Burd and Tom Thorp.

Ms. Ciesla acknowledged and thanked the municipal Mayors and Committee/Council members and former Mayor Steve Lonegan of Bogota, for being present.

Ms. Ciesla took a moment to acknowledge our partnering services in attendance, Domestic Abuse & Sexual Assault Crisis Center (DASACC), President Dr. Austin of the Warren County Community College, along with the College Foundation members and members of the Vo-Tech Board. She thanked them all for all that they do.

Mr. Sarnoski thanked Commissioner Director Ciesla for the opportunity to speak, as well as congratulated her on her appointment as director.

Mr. Sarnoski remarked, as he starts his fifth term as freeholder/commissioner, he took this opportunity to thank his family, wife Tammi and children, Skyler and Jason. Without their support none of this would be possible.

Mr. Sarnoski expressed his thanks to our new Surrogate Mike Doherty, who has sworn him in for the fifth time.

He also, thanked his fellow Commissioners, Lori and Jim, "We have the best working Commissioner Board, in my opinion, in the best county in the State of New Jersey."

Mr. Sarnoski thanked all of his friends and volunteers of Warren County. He also thanked the employees of Warren County, "without their successes we would not be successful."

Mr. Sarnoski thanked the voters of Warren County, for their constant faith in him. "Their trusts that I hold their values as my values, is what drives me to work harder each and every day." Mr. Sarnoski reflected on all the hard work over the last twelve years and how much we have accomplished over that time. When he started, the county was in the middle of a housing recession, with an unstainable budget and increasing debt. His early years as freeholder were spent righting the ship. Reducing the size of county government, giving our voters control over their debt. After that reducing spending to the lowest amount in a decade became easy. Eventually, county debt was eliminated and a sustainable controllable budget was created. The budgets can weather the changes in the economy, a pandemic and countless curve balls thrown at us by out of control state spending.

Mr. Sarnoski continued, at the same time we preserved thousands of acres of farmland and open space. We helped build one of the most successful county colleges in the country. We have created strong capital infrastructure in county government that is one of the most admired in the state. "With all that we have accomplished I feel the challenges that we faced are the easy ones and the hardest battles that we have are still ahead of us. Because the challenges of past, are the ones that we had, were fully out of our control. The challenges of the future are the ones that are being thrust upon us." Debt was eliminated when we put the voters in charge of their borrowing and save for future projects. With the out of control state spending, double digit health and pension increases, pushing burden on local governments, controlling the costs of government continues to remain a challenge, especially for our municipalities. The county wisely saw these increases coming and got out of the State Health Benefits Plan and next year we will have a budget that does not increase taxes for health care costs and will not push that burden onto our employees. We've met that challenge and faced it, now we are trying to help the municipalities face their challenges.

It is easy enough for us to create a strong education system in Warren County with our county college and county technical school by educating for the jobs of the future. The state continues to push an agenda that takes critical education time away from subjects like, reading, mathematics and focuses their radical liberal agenda in our schools, which is why New Jersey test scores continue to decline. "I will continue to fight for our children's education and our parental rights in that education, so that we can have a say in what our children are learning." It was easy for the County Commissioners to support our public safety in our 2nd Amendment rights. We asked the courts to address the backlog of carry permits, and we support the Prosecutor's Office to go after criminals, especially those that are targeting our children. Meanwhile, the state continues to pass laws that make it easier on our criminals, unconstitutional restrictions on our 2nd Amendment rights. I will always stand up for our resident's public safety and their right to protect themselves.

Warren County has continued to push for proper planning and stronger laws that support cooperation in the planning process in the municipalities to be sure that towns are not over burdened by development. It has become obvious that this state is focusing on issues that do not exist like the rock fall on Route 80, while ignoring important issues that do exist, like deficient intersections and overdevelopment.

Mr. Sarnoski remarked, Warren County will continue to work with all of our municipalities and work toward developing a traffic plan that considers all of our towns concerns and directs trucks off our local and county roads as quickly as possible and onto the state and federal road where they belong.

Mr. Sarnoski said, "I will be addressing all of these issues true to my values, values that got me here. By remembering the bigger and more intrusive and expensive government is never the answer, by remembering that we have a strong constitution that allows us to protect ourselves and by what we believe in. By working with others that share these values. That is what I have always done, and that has made us strong in Warren County despite the challenges that the state puts on us, and this is how I will continue to lead Warren County into the future. I thank you all for support, God Bless you and God Bless Warren County."

Mr. Kern was next to speak. He wished everyone a Happy New Year and congratulated Commissioner Director Ciesla along with reminisced on a meeting or two of their municipal meetings together.

Mr. Kern thanked Commissioner Sarnoski for his leadership for this past year and for always keeping the tax payers in mind when making decisions.

Next, Mr. Kern congratulated "some similar faces in different places this year", Michael Doherty as Surrogate, Senator Doug Steinhardt, along with Congressman-Elect Tom Kean, Jr. Commissioner Kern remarked he looks forwarding to working with them all.

Mr. Kern concurred with the comments of Mr. Sarnoski, Warren County being one of the most responsible governments in the State of New Jersey. Warren County essentially has no debt and we will continue to move in that direction over the next few years.

Mr. Kern commented on the good representation we have throughout the state and country, which includes Mayor Tim McDonough who sits on many boards and advocates for us in Trenton, along with other strong representation in Trenton. This includes Senator Dough Steinhardt, Senator Steve Oroho and Assemblyman John DiMaio. Mr. Kern mentioned, "I, myself am honored to follow in the footsteps of Freeholder Gardner who served on the NJAC Executive Board of the New Jersey Association of Counties. I will continue to advocate for issues affecting counties that the state is putting on undue regulations on us."

In closing Mr. Kern, as a former mayor, "I know what the county has done over the past few years, in working and trying to establish strong relationships with our municipalities. The regulations and bureaucracy that comes out of Trenton makes your job so hard to do when you are dealing with such small amounts of staff in your communities." Mr. Kern challenged our towns to help encourage and tell their residents, make them understand the different levels of governments. "The county is not an appellate court, we cannot over rule you. New Jersey is a home rule state, take that challenge and run with it, you have control of your own destinies and please take the challenge in 2023. If the State of New Jersey has elected leaders like we have in our municipalities around our county we will be in a much better state." Mr. Kern expressed his appreciation for all the work that everyone does here, he looks forward to taking on the challenges in 2023. "I wish you all a Happy New Year."

Ms. Ciesla came before the audience and thanked everyone for attending the 2023 reorganization meeting. She also thanked her colleagues, Jason and Jim for putting their faith in her to lead the Board this year. "I am excited and thrilled to be doing so, and very grateful for their support and their teamwork. We are truly a great team and I am lucky to serve with them."

Ms. Ciesla also thanked Congressman-Elect Tom Kean, Jr., for swearing her in today and congratulated him on his win.

She also took a moment to congratulate all that had ran this year.

Ms. Ciesla has expressed her thanks to her friends for attending and their support.

Ms. Ciesla started her speech with a joke, you may look at us and think, "I am the mom of the group, and usually that is true, but sometimes I must admit I am a willing participant in some of the harmless shenanigans these guys pull on each other."

Ms. Ciesla commented, she is honored to be the first female Commissioner Director. It has only been forty years ago, in 1983, that the first female ever, Irene Smith, was elected to be a freeholder in Warren County. Only three other women have been freeholder since then, Ann Stone, Susan Dickey, and herself. Ms. Ciesla was elected as a freeholder, then the title was changed when she was sworn in. It has been over twenty years since we had a female director. Ms. Ciesla remarked that your gender does not regulate whether you will be a good leader as leadership is not a quality that is just determined by your DNA. She commented on the low numbers of women in government positions even until today. Ms. Ciesla stated, "I am honored and grateful to be part of the positive statistics of female politicians."

Ms. Ciesla quoted Vince Lombardi, "Leaders are made, they are not born. They are made by hard effort, which is the price which all of us must pay to achieve any goal that is worthwhile." This is true of both men and women, not only from their own hard work but those of them that are for them and those of them that support them. As a female elected official, I want to highlight the hardworking women before me because this year also marks the 150th anniversary of when Susan B. Anthony was arrested, tried and convicted of registering and voting of the previous year's Presidential election. Also, 110 years ago in 1913, New Jersey's own Alice Paul, helped form the congressional union for women's suffrage to lobby for the constitutional right to vote which they achieved seven years later. If that doesn't constitute hard work for the benefit for all of us, I don't know what does. I am very thankful for the female leaders that have paved the way before me and I hope to be an inspiration to those who will come after me.

As leader of the Board of Warren County Commissioners for 2023, I promise I will work hard with Jim and Jason for everyone in our county. We will continue to focus on the issue that helps us maintain our Warren County way of life. "Thankfully, our county is in very good shape due to my current colleagues and those that have served before us." We are likely, as Jason has mentioned, they only county that will not have a health care cost increase due to proactive measures that they took years ago

to get out of the State Health Benefit Plan. As others across the state are facing a huge increases of nearly twenty-five percent we will not have any.

Additionally, our pay as you go methodology is allowing us to improve buildings, such as the courthouse and building new buildings and without incurring debt burden for our tax payers. We are currently working on the plans for the new Department of Human Services building, reconfiguration and upgrades of our admin building, and we have begun the process of planning for renovations for the Catherine Dickson Hofman Branch. We will continue to enhance our buildings to meet the needs of our residents of today and for those of the future. We are looking to implement solar power for our buildings were we can, including EV charging stations to service our electrified fleet in years to come. All of this will be done with an eye on the bottom line. Ms. Ciesla stated, "We understand that our dollars are really your dollars and they do not grow on trees."

Ms. Ciesla, touched on education. Education is key to success, the improvements of WCCC staff and board are making our already top rated county college are all she could dream of and more. "They are putting us on the map to be the educators to be the jobs of the future including future support of our agricultural community and businesses." The county vo-tech high school is just as successful in delivering a great education along with technical skills to our students and they continue to grow and adapt to the needs of our community. The college and vo-tech have been streamlining their processes to maximize their budget dollars.

Ms. Ciesla spoke of the volunteers. "All of our volunteer boards are filled with dedicated volunteers looking to do the best that they can for our county. We cannot thank you enough." Ms. Ciesla acknowledged employees who are hardworking and cream of the crop in the state of New Jersey. "Our employees are the major reason why this county is the best place to live," in my humble opinion. The pandemic pushed them all to the limit, and they not only met but exceeded expectations on those challenges. As we come out of the pandemic, we still have a lot to deal with, particularly in human services. "Thank you to all of our employees for helping those that need it most along with our local partners who assist in those efforts."

Ms. Ciesla, discussed her goals for the year. She plans to continue to be proactive and creative to preserve our way of life here in Warren County.

Communication is a major component of that and we are currently working on investigating what upgrades are needed for our emergency management systems, as well as studying the current state of cellular service in our county and petitioning our cell providers for upgrades and enhancements. The cellular drive test will be occurring this month. This will help us pin point where we need upgrades the most. The lack of broadband altogether in parts of our county is another major focus for us. We are presently working feverishly with the NJ BPU and their consultants to challenge the new FCC Broadband coverage map, which needs a lot of challenging. We need to do this by January 13th, 2023. Mayors have been emailed about this already, and Ms. Ciesla will continue to follow up. More money we can get into New Jersey, the more money we can get into Warren County. Ms. Ciesla has been in touch with our two state Senators, Senator Oroho and Senator Steinhardt, they are committed to helping us getting the funding we need so we can get the whole county online once and for all. The pandemic highlighted the lack of broadband in our area and if the federal government wants to finally give New Jersey back our federal tax dollars we must do what we can to truly get what we deserve. Beyond improving our needs of communications, we will also improve on what we communicate to all. Whether it be about our services, events or businesses we want our public to be well informed. We will continue to support our local businesses that help us maintain our Northwest Jersey rural character. We will fight hard against any state legislation that hurts us and we will work with our legislators to craft legislation that helps us.

Ms. Ciesla spoke of the big event on the horizon that will help us promote Warren County, our towns and businesses all throughout the state is our upcoming Bicentennial celebration in 2025, Warren County will be 200 years old, and we are planning a multi-year long party. We are not only looking to highlight our history, but present and our future. We have so much planned, if you would like to join us in the planning, we would love your help.

In closing, Ms. Ciesla stated, "We know we have challenges ahead too, and we will meet those head on and do all we can to do what is best for our county. I will never pretend to know all the answers because that is not how we learn to grow. My door will always be open to hear ideas and suggestions. I look forward to working with everyone in the upcoming year." She ended her speech with a quote from the great Walt Disney, "Around here, however, we don't look backwards for very long. We keep moving forward, opening new doors and doing new things because we're curious... and curiosity keeps leading us down new paths." "Our curiosity will help us find innovative ideas to meet our goals and maintain our character and the team we have assembled to serve our residents is curious and forward looking. Our future in Warren County is bright and I am very honored to be a part of it. God Bless you all
