As always, the Freeholders expressed appreciation to those serving in volunteer capacities.

Reports and Comments

Assistant County Counsel Joe Bell IV said he had one matter regarding litigation for discussion in Executive Session.

County Engineer Bill Gleba reported that the Still Valley Road Bridge was scheduled to be closed either Monday, March 5 or March 12 for about three days. Signage in the area was also being augmented.

County Planner Dave Dech announced that the Pollution Control Financing Authority (PCFA) would be conducting electronics waste recycling on Sunday, April 15 from 8:00 a.m. to 12:00 p.m.

Regarding the Route 57 Scenic Byway endeavor, Mr. Dech said some appointments to the committee are required. He had already approached Public Information Director Art Charlton and Land Preservation Director Corey Tierney who both agreed to come on bard assuming the Freeholders approve. One more member is needed. Mr. Dech asked them to appoint someone unless any of the Freeholders would like to appoint themselves. The next meeting of the group is scheduled for May 22 at 7:00 p.m.

Mr. Smith was pleased about the electronics recycling, saying it has been a long time coming. Mr. Marvin asked if this would be a once-a-year event. Mr. Smith said they may have a container there, but details have yet to be determined.

County CFO Dan Olshefski said the County Budget has been submitted to the State, conforming to compliance standards. He said revenues are up slightly compared to this time last year so we're moving in the right direction.

County Administrator Steve Marvin said there was one late addition to the Vacancy Report. The Freeholders had no questions or comments on the report. Mr. Marvin had been in contact with Ed Zalewski of Warren County Technical School regarding its annual Board of School Estimate Meeting normally scheduled between the fourth Tuesday in March and April 8, but the new Governor's budget address is being delayed. Hence, the Freeholders consented to Mr. Zalewski's request that the meeting be held at 6:30 p.m. on April 11, prior to the Freeholder Board's regularly scheduled meeting. Mr. Marvin noted that it was likely that there would be no Board of School Estimate Meeting for Warren County Special Services School District as it is working its way out of business.

Freeholder Comments

Mr. Gardner spoke of efforts to work with the PCFA to determine how to recycle agricultural plastic waste. Mr. Dech said he thought there was a place in South Jersey that accepts agricultural waste. He said it is definitely eligible for recycling, but there are issues regarding how clean it needs to be.

Mr. Gardner said all three Freeholders received a copy of Atlantic County's resolution opposing State legislation that could end up in awarding pay raises to State officials and State executive level officers. He concurred with the resolution and hoped to have one prepared for the next meeting. Mr. Smith agreed as the County ultimately has to pick up the tab.

Mr. Sarnoski had plans to attend a behavioral health meeting the following day at St. Luke's Warren Hospital. He expected to find out about some executive leadership changes. He confirmed that Mr. Gardner was in possession of the certificate to be awarded to an Eagle Scout over the weekend. Speaking of scouts, he said he was honored to have been asked to be the Good Scout this year, along with Hope Councilman John Kruk. He said he was following in some good footsteps (his fellow Freeholders).

Mr. Smith said it had been a busy week for him with NJ DEP matters and working through all the issues with Personnel and the CFO regarding the proposed health insurance switch. He said he was very much encouraged as things moved forward.

Mr. Smith had attended the new Fire Chiefs' Meeting and said it was good to see how many people continue to stay involved and the amount of effort put into training. He participated in a bicounty training drill held at a pharmaceutical site in Bloomsbury. It was good to see the coordination of the two counties, though somewhat disturbing due to how realistic the exercise was.

Closing Public Comments

Donna Diorio of Washington Street in Columbia said there were severe speeding problems on her road which runs parallel to the river. She had approached the Knowlton Township Committee who told her it was a State road and inexplicably advised her to approach the Freeholders. The State was supposed to have conducted some sort of study, but she had been unable to obtain the results. Mr. Sarnoski asked if she had contacted the State Police. She said she had; an NJSP representative attended a recent municipal meeting. Speed humps were discussed, but decided against. She thought it would be nice to have a three-way stop installed. Mr. Gleba confirmed that this was the old state highway.

Mr. Smith explained that this was not the County's jurisdiction, nor does the County have a law enforcement arm. Knowlton relies on State Police. The local and state officials would need to get together to authorize a stop sign. Mr. Gardner thought the State should have deeded the road to the township years ago. Mr. Gleba said the whole area is a "quagmire" of state, county and municipal road jurisdictions. He thought it would be worth a phone call to the Hope State Police Barracks.

Mr. Smith suggested reaching out to the District 24 Legislative Office which would have the ability to talk to the NJ DOT and perhaps have one of their representatives come out to a meeting. He said he was sorry Ms. Diorio came out to this meeting since the Freeholders have no jurisdiction in this area. She said it was okay; she found the meeting interesting.
