WHEREAS, the Board of Chosen Freeholders of the County of Warren finds it advisable and necessary to increase its CY 2018 budget by up to 3.5%, subject to certain exceptions, over the previous year's final county tax levy, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Board of Chosen Freeholders hereby determines that a three and one half percent increase in the budget for said year, amounting to \$ 534,705 in excess of the increase in final county tax levy otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS,** the Board of Chosen Freeholders hereby determines that any amount authorized herein above that is not levied as part of the final budget shall be retained as an exception to final county tax levy in either of the next two succeeding years.

# **MINUTES**

Six years ago, I was a lone "no" vote on the County Budget because at the time, I felt the County was not addressing some serious fiscal issues facing us. We were using surplus and were looking to cut where I felt we couldn't cut. I feel we have come a long way since then and we've made some smart choices and good decisions that have led us to this budget we have before us today. While it is no secret that I feel that this budget cuts more than we should from the tax levy, I don't feel that it cuts more than it can cut, but I stress that municipalities and taxpayers should not expect a tax cut such as this in the future. I cannot give all credit for this tax cut to the increase in the Transportation Trust Fund money. Instead, I credit the smart choices and difficult decisions this Board has made over the past few years for where we are today. We maintained strong roads without borrowing when the Transportation Trust Fund was not as well funded which allows us to give back more now because we are well positioned. If we have the need in the future, we may have to bring the County portion of the road funding back up to address additional work should we have the resources to accomplish it, but that's an issue for a future year; not this year.

My biggest fear for the future of the County Budget in years to come is not in our control. It is the current Governor and his administration that seems determined to raise taxes and the fiscal burden on local entities, middle class families and business owners. Just yesterday, Governor Murphy presented his plan for our State's Budget and its future. This includes a raise of the sales tax, a promise already being broken from when it was decreased due to the gas tax legislation, and I'm worried that the other part of that negotiated decrease, the Estate Tax, is not far behind; and an increase in the minimum wage to \$15/hour that I'm sure will seriously hurt our small business owners and seasonal business on which much of Warren County depends. The loss of these businesses and the jobs they create will seriously hurt our tax base and free County College tuition will have an impact on the way we fund and manage our County College and potentially increase our cost to maintain the quality institution that the College and the Freeholders have created. This just names a few of the issues the current administration has created for us.

All of this will be paid for by a tax on millionaires that will drive out the only people who, due to their financial resources, can afford to leave the state. The proposed legalization of marijuana, aside from its moral costs, will increase the burden on our local social services and public safety organizations who fight the issues that addiction inevitably brings with it. This will further cripple our financial resources. Meanwhile, the administration takes from us, the only tools we have to fight tax increases such as the two percent Cap on interest arbitration that Director Smith rightly points out in his budget comments.

This is not to say that I am not proud of this budget or the work we have done. I only stress caution. We got to where we are today because we did not budget in a one-year box. We have been forward-thinking, knowing that Warren County will exist for many years and many boards to come and the decisions we make today impact the future. As long as I am blessed to have this position, I will continue to think that way. Having said all that, I am proud to vote "yes" to a budget that was, due to the long, hard efforts of this whole board; and pray for a future that is bright for our county, our state and our country. Thank you.

Thus concluded Mr. Sarnoski's remarks. He apologized for being "a little long-winded", but wanted to make sure he addressed some of the concerns of Governor Murphy's budget address and what he thought the future could potentially hold for county funding.

Mr. Gardner's remarks began with an expression of thanks to department heads. He said they plan their budgets very carefully with the Freeholders' concern for the taxpayers in mind which is why we don't have big spending in Warren County. He expressed appreciation to the County Administrator for keeping his finger on the pulse in this county as well as County Counsel for trying to mitigate the problems as they arise. "We are in great shape," said Mr. Gardner.

In terms of the State of New Jersey, while the County has been able to deal with everything imposed on us, Mr. Gardner said the Highlands Act of 2004 has made it very difficult to attract new businesses. It is even challenging for existing businesses to amend and augment their business plans here.

In terms of this year's County Budget, Mr. Gardner said he thought we were in the right place. "We have room; we have enough budget surplus; we're in a very good position." The question becomes how much of the public's money do you need to save? That is a balancing act. Each member of the Freeholder Board may have his own opinion and respectfully disagree. "I felt we had good cushion and I think we'll have good cushion in future years," he said.

Regarding Mr. Sarnoski's concerns about keeping an eye on what the State of New Jersey does, Mr. Gardner said he had a personal conversation with Senate President Steve Sweeney a few weeks ago who made assurances that he would not sign anything to raise the Estate Tax. "I think there's going to be pushback against this governor if he tries too many things too soon," Mr. Gardner said, but overall, he was pleased with the County's position.

He was pleased that we were going to have a brand new library this year. In 2017, Warren County was recognized as the most improved Library System in the State of New Jersey. "We have made improvements for the public and it's your money and we expect to do that time and time again," said Mr. Gardner.

Mr. Smith then took his turn to remark on the budget. He clarified that the budget component of this was not where the Board was able to cut. We were able to cut in capital. We did not have a surplus from the operating expenses side. While he applauded efforts of department heads to keep costs down, by the time we were done with contract negotiations and things like that, we ended up nearly at the Cap. The capital side is where we were able to come up with the extra. "The fact that we were in a position fiscally to be able to move forward has been a cumulative effort of this Board, some very difficult meetings and also everybody on staff because we were able to keep our capital costs under control. The other portion of the tax cut would be in the Open Space which is a retirement of debt, so I think if we're genuine here, I think that we've bargained in good faith. We are truly constrained by the two percent Cap on the operating side... for the most part, our labor negotiations and operating expenses have increased at the Cap level. The good part is that we have been able to control our capital costs through reduction of debt and also in terms of projects."

### **MINUTES**

Addressing Mr. Sarnoski, Mr. Smith said, "I share your concerns in terms of the fact that it does not appear that the commitment to control property taxes moving forward is as clear with this administration as it was before and I have to say, it was somewhat muddled towards the end of the last administration. So, we'll deal with those challenges and move forward and do the best we can."

County Engineer Bill Gleba said repair work to the Still Valley Road Bridge in Pohatcong Township had to be postponed. They didn't want to close the road down after all the damage sustained from the last storm. The roadway is scheduled to be closed down on Monday, March 19 for about three days.

County Planner Dave Dech reported having received the certification letter from the NJ DEP on our Solid Waste Plan Amendment that called for the expansion of the landfill. The one requirement in the letter is for us to update our recycling plan; a process already being undertaken by SWAC (Solid Waste Advisory Council) and due by the end of this year. The State's goal is to recycle 50 percent of solid waste and the County's latest numbers are 35 percent.

County CFO Dan Olshefski made a joke about getting started on the 2019 Budget.

County Administrator had only the latest Vacancy Report.

# **Freeholder Comments**

Mr. Gardner had plans to attend an NJAC Meeting the following week and expected a very full agenda.

He spoke for a few minutes about the widespread power outages resulting from recent storms. He received several phone calls from residents and elected officials. After Superstorm Sandy, he said, he thought we had some progressive and productive meetings with JCP&L resulting in changes in protocol that he thought went well. He talked about how rare it was to lose power around here when he was growing up and into his 30's. Mr. Gardner had a feeling that there was an issue with JCP&L being owned by First Energy. "I think sometimes they're pennywise and pound foolish," he said. When JCP&L had its own crews, it seemed better than it is now. He wondered if there should be another meeting with JCP&L to achieve changes. "It shouldn't have been the magnitude that it was all around this county," he said. Something has to change.

Mr. Sarnoski said it is no secret that he works for JCP&L, but he doesn't own the company. He said Mr. Gardner's comments were valid, but not directed at the crews out there working hard. Mr. Sarnoski wanted to thank all the workers, especially our County Road Crews and Public Safety officials who work as best they can to restore roads. He received no complaints about the condition of the roads and asked that Public Works Director Alex Lazorisak take the compliment back to the workers.

Mr. Sarnoski said he agreed with much of what Mr. Gardner said and was interested in getting involved in bringing some parties together as a JCP&L employee and County Freeholder to talk about different ways to improve in the future.

Mr. Smith said it was worthy of mention, the genuine effort on the part of JCP&L to get power back. It was a very broad storm and it pulled resources from neighboring areas since we were so severely impacted. He was unhappy with Verizon's response to felled telephone poles. "It's not a JCP&L problem alone," he said. It was a challenging situation and Mr. Smith was out of power for six days.

Regarding the PCFA, Mr. Smith said there has been headway and we've moving in a positive direction. He thanked Mr. Dech and County Counsel for their efforts.

Mr. Smith attended Family Promise and Abilities events. He said it was nice to see the community helping itself and doing things we can't address with the resources that we have. It's a great cooperative effort.

Finally, Mr. Smith reported having attended a meeting on voting machines earlier in the day. The Election Board is actively seeking proposals. There are many factors to consider and the County has been involved in trying to find upgraded solutions and have been budgeting accordingly. Bilingual requirements are coming and machines must accommodate people with disabilities.

There were no closing comments from the public, but Mr. Marvin asked where JCP&L representation was this evening. He found the absence odd.
