REPORTS AND COMMENTS

County Counsel Joe Bell IV said he had one brief matter for Executive Session regarding litigation.

County Engineer Bill Gleba reported that the annual traffic crash report has been released and copies were distributed to the Freeholders, county departments, municipalities and police

departments. He had additional copies for anyone interested. They will also be available in his office.

In late August, Mr. Gleba said our 2019 County Aid allocation from the NJ DOT had been received. It will be the same amount as last year - a little over four million dollars.

The County's 2018 road resurfacing program is currently underway. Mr. Gleba said work is being done on CR 517 in Allamuchy from Interstate 80 to the Sussex County line. The following week was to be the Warren Glen area in Pohatcong. "We'll see how far we get this year; it's really dependent upon the weather," he said, adding it is an aggressive program that may have to go into next year.

Point Mountain Road is now closed where our inter-county bridge structure with Hunterdon is located. Mr. Gleba estimated it would remain closed until about March 2019.

The NJ DOT is working on some bridge reconstruction on County Route 608 – Silver Lake Road. Mr. Gleba anticipated that should be done within the next couple of weeks.

Mr. Smith inquired about that "little spot" near Interstate 78. Mr. Gleba said they put in a request to do that through the Morris County Co-op. The numbers seemed favorable compared to the amounts received from the bid. The co-op is somewhat backed up, but Mr. Gleba hoped it would be done this year.

Regarding the aid allocations, Mr. Sarnoski encouraged future planning to rebalance the financing. "Because we don't want to leave that money on the table," he said. Mr. Gleba said, "I can assure you we already have the money earmarked for projects next year and then some for budgeting purposes."

The increase to the gas tax was mentioned, and how this funding increase would not have been possible without it. The impact to our property tax levy would have been staggering.

County Planner Dave Dech reminded everyone of the paper-shredding event to be held on September 22. A recent electronic waste collection program received about half the amount of vehicles that had participated in the one held the prior spring. Mr. Dech said he arrived at 11:00 a.m. and had to wait about five minutes. Mr. Smith said that was good; we are getting caught up with the backlog. The PCFA is planning to set up a somewhat permanent site for this purpose.

County CFO Dan Olshefski was away.

County Administrator Steve Marvin had only the Vacancy Report, noting a number of retirements, but nothing unusual.

FREEHOLDER COMMENTS

Mr. Gardner planned to attend an NJAC meeting later in the week, as well as Preservation Day over the weekend, being held at the Roseberry House in Phillipsburg.

Mr. Gardner reported on a recent Municipal & Charitable Trust Fund Committee meeting, saying he was pleased with the new procedure of committee members going out in the field to view properties prior to the grant applicants coming in, so they are prepared with detailed questions.

The previous day having been the anniversary of the September 11 terror attacks, Mr. Gardner said this was a very important day in the history of our country, hoping we never see anything like that again. We need to protect America. The Patriot Day ceremony at our 911 Emergency Services Memorial has been rescheduled for October 13.

Mr. Sarnoski spoke of having attended a candlelight vigil in August to remember those lost to the opioid crisis. It was very well attended; he was shocked by how many families have been affected in Warren County. He announced a resource fair for addiction services - including a panel discussion - to be held on October 12 at Warren County Community College.

Regarding the upcoming election, Mr. Sarnoski took a few moments to talk about another unfunded mandate by the State of New Jersey. He explained that anyone who requested a vote by mail ballot for the 2016 election would have to continue to vote by mail unless opting out in writing to the County Clerk's Office within just a few days of receiving the notification. The short notice is not the fault of the County Clerk's Office; staff had to hastily organize a mailing to comply with the new law passed in August. Those who do not opt out in writing but show up to the polls to vote will have to vote provisionally, which is another process. Those votes will have to be manually counted, slowing down the process. This law provided no funding for paper, postage or printing. Mr. Sarnoski said this is another poor decision on the part of the legislature, for which we are paying the price.

Mr. Sarnoski noted that the reason the Patriot Day ceremony was rescheduled was due to the death of Steve Matuszek. Matuszek was a public servant who had retired from the Warren County Prosecutor's Office; was involved in various Public Safety divisions, including instructing at the Fire Academy; was a former Chief of Mountain Lake Fire Company; and was involved in the Special Olympics. He passed away after a long, tough battle with cancer. A moment of silence was observed in his honor.

Mr. Smith reported having the opportunity to attend the Governor's Economic Forum in Parsippany, predominantly based on tax abatements. The concept that existing taxpayers are supposed to pick up the costs of new residents moving in makes Mr. Smith uncomfortable. Businesses that have been in existence for decades should not be looking at a greater tax burden to invite competition. He brought up that topic, as well as the challenges of the Highlands Act.

Mr. Smith looked forward to the new library dedication on September 22. While this is a

happy occasion, we do need to work to fill the void and address concerns in the Washington area in terms of library services.

Domestic Abuse and Sexual Assault Crisis Center held a fundraiser recently. Unfortunately, these are very real problems that do exist in our area, and the organization has experienced a loss in funding from the County because of peer group funding changes. The organization is making an effort to reach out and continue to provide these services.

CLOSING PUBLIC COMMENTS

Purchasing Agent Christopher Pessolano reported on the County's annual surplus auction held the prior weekend, which brought in about \$56,000. Some towns were involved as well. A future online auction for a tractor-trailer is already generating some interest. Mr. Pessolano thanked Public Information Director Art Charlton for taking photos, and the Road Department and Buildings & Grounds for their help and cooperation.

Warren County Technical School Superintendent Ed Zalewski provided some information regarding the school's opening. It had 133 freshmen show up for orientation; 28 new LPN students for the night program; a total of 475 regular students; and 10 new staff members. He said the most popular programs this year are Cosmetology, Culinary Arts, Health Sciences, Engineering, and Law & Public Safety. He said the year is off to a great start.

Mr. Gardner inquired about carpentry and welding programs. Mr. Zalewski said they are working on it, starting evening recruitment programs with parental involvement. He found it is more about convincing the parents than the students. He said welding is doing well, with a couple of female students outpacing the males. Recruiting also continues in the grammar schools and on social media.
