WHEREAS, the mission of the New Jersey Scenic Byways Program is to recognize and preserve New Jersey's unique historic, cultural and natural heritage; improve roadway safety and appearance; create and nurture partnerships among citizens and all levels of government; provide opportunities for commerce through heritage, cultural and nature-based tourism; enhance quality of life and instill pride in local communities; and

WHEREAS, the scenic byway can further benefit the community by fostering economic development consistent with the regions rural character, providing access to local parks, waterbodies and unique natural vistas; and

WHEREAS, the six municipalities that are located within the designated Warren Heritage Scenic Byway filed resolutions of support for the scenic byway designation and include the Township of Franklin, the Township of Greenwich, the Town of Hackettstown, the Township of Mansfield, the Township of Washington, and the Borough of Washington; and

WHEREAS, these six municipalities worked together with Warren County as the Route 57 Scenic Byway Committee and assisted in designating the byway in 2009 and completing a corridor management plan (CMP) in 2011; and

WHEREAS, public meeting opportunities were provided to obtain public input from the general public throughout the application and CMP process; and

WHEREAS, the byway name was revised from the Route 57 Scenic Byway to the Warren Heritage Scenic Byway (WHSB); and

WHEREAS, a formal organization referred to as the Warren Heritage Scenic Byway Committee (WHSB) consisting of members of the six municipalities, Warren County government agencies and committees, business improvement districts, and other interested non-profit organizations now meet quarterly to monitor implementation of the Corridor Management Plan and to assist the stakeholders, individually and collectively, in dealing with matters concerning the Warren Heritage Scenic Byway and its communities; and

WHEREAS, the Warren Heritage Scenic Byway Committee realizes that this important resource would benefit the public by being extended to the Delaware River in the west and to Waterloo Village in the east; and

WHEREAS, the route of the Scenic Byway, is recommended to be amended and lengthened through the acceptance of all municipalities and counties along this extended WHSB Route; and

WHEREAS, the southern extension of the byway begins at its western terminus at MP 2.07 at the Greenwich/Lopatcong Twp. border, and travels south on NJ 57 to County Route 519 south. Continuing on CR 519 south through Lopatcong, Greenwich, and Pohatcong Townships, the route proceeds to the intersection with NJ 122 (South Main Street) and turns right. Staying on South Main Street, (NJ 122, CR 678) the byway ends at Union Square in Phillipsburg.

WHEREAS, the northern extension of the byway begins at the eastern terminus at the intersection of NJ 57 and State Route 182 (Mountain Avenue), and continues north on Route 182, turns left onto Route 46 (Mill Street) for 1 block before turning onto County Route 604 (Willow Grove Street), Staying on CR 604 through Hackettstown and Allamuchy Township the byway route proceeds through Allamuchy Mountain State Park and then ends at Waterloo Village in Byram Township, Sussex County; and

WHEREAS, extension of the byway route involves a coordinated effort and support among the additional municipalities and counties through which it passes; and

WHEREAS, an application to extend the designated byway must be prepared and submitted to the New Jersey Department of Transportation for approval; and

WHEREAS, administration of the extended byway, once formally designated, further requires continuing commitment in the form of participation of the County of Warren as an active member of the Warren Heritage Scenic Byway Committee; and

Mr. Sarnoski said he was glad to see the PCFA would now be operating with a full board.

REPORTS AND COMMENTS

County Counsel Joe Bell had a few matters regarding litigation for Executive Session.

County Engineer Bill Gleba advised that the 2018 road resurfacing contractor is back and starting up work on CR 609, so work will be performed from Route 46 up to Hope and back onto Route 519 down to where we ended last year, plus another small portion near Hunterdon County. Last year's heavy precipitation set things back a couple of weeks, so Mr. Gleba anticipated the work would be completed around mid-May.

County Planner Dave Dech had no report

On behalf of the County CFO, Fiscal Analyst Kim Francisco reported that the State had reviewed our budget, came back with a short list of questions, and his office replied with clarifications earlier today. He expected to be on schedule for budget adoption on March 27.

County Administrator Steve Marvin had only the Position Vacancy Report for approval.

FREEHOLDER COMMENTS

Mr. Kern mentioned a couple of meetings he planned to attend the following day: the inaugural meeting of the Transparency and Technology Task Force and the Economic Development Committee meeting. The findings of the Grown in Warren presentation were to be discussed at the EDC meeting. Mr. Kern asked for his colleagues' opinions on the best way for the EDC to provide its input regarding how to proceed on report's recommendations. He said he had spoken to committee chair Betty Schultheis about potentially forming one or two subcommittees, with one focusing on agriculture. Mr. Sarnoski noted that an Ag representative already sits on the EDC, who had been very involved with the Grown in Warren project. He agreed it was a good idea to form a separate group to focus on an action plan.

Mr. Gardner pointed out that the legislative dinner for the Ag Board was to be held the following week. He thought that was a good venue at which to raise the subject, to hear feedback from some board members to gain their perspective. Mr. Kern agreed, and planned to attend a Chamber of Commerce dinner with Land Preservation Director Corey Tierney to share the Grown

in Warren findings there as well. He thought that would also be a great opportunity to get the message out there.

Mr. Kern mentioned the recent passing of a longtime Warren County elected official, Sal Vangeli. He had served as mayor of Pohatcong and had been in elected office for close to 40 years.

Mr. Gardner reported he would be attending an NJAC meeting the following week. A lot is happening, he said, some of it very difficult. Regarding the Ag legislative dinner he mentioned earlier, he thought both of his fellow Freeholders should try to attend. The Hackettstown Cooperative will probably be discussed, and he hoped for some good news there.

Mr. Gardner then mentioned an article regarding shrinking enrollment in 17 Warren County school districts. This is significant, and he thought it was time to get a handle on the cost of education. A downturn in the youth population is a serious issue that can lead to other problems. He hoped communities would be able to successfully deal with this, but maintaining a stable population is vital.

Mr. Sarnoski said due to the declining school population, we are losing State aid, so our school taxes will go up. In his own district, Great Meadows Regional, they are talking about consolidating schools. Mr. Kern added that "This isn't a 'today' problem; this is going to be a problem for the next five, 10, 15 years," as those children progress through the grades. The younger classes following them are probably not going to make the situation any better.

Meanwhile, Mr. Sarnoski said, the State continues to divert funding to towns like Hoboken, which is very wealthy, as well as Jersey City and Newark. Schools continue to be the number one driver of our property taxes.

Mr. Sarnoski began his comments by announcing it appeared that an agreement was in place to have a library drop-off box placed at the Washington ShopRite, so it should be there soon. He indicated to Art Charlton that he would like a news release with a photo once it is in place.

The following Thursday was to be the second Addiction Task Force meeting of this year, Mr. Sarnoski announced, and a donation was to be presented to Parent to Parent Addiction Services, Inc., which helps families affected by opioid addiction in various ways. The donations were courtesy of task force co-chairs and the Election Board.

Mr. Sarnoski looked forward to providing welcoming remarks at Centenary Stage Company when it hosts the U.S. Army Jazz Ambassadors in concert on Saturday, March 16. Warren County is proud to host this band, offered as a free concert event.

Mr. Sarnoski asked Mr. Lazorisak for an update on the Still Valley Road closure. Mr. Lazorisak said unfortunately, the water level has risen a bit due to melting, so there is essentially no change. We need some dry, warm weather from Mother Nature.

Mr. Sarnoski said he has told Hardwick Township's mayor the same thing; we just need to wait for the warm weather. He urged those affected to remember the Freeholders set aside \$50,000 for engineering and planning to work toward a long-term solution. Mr. Lazorisak said he would report back in two weeks.

CLOSING PUBLIC COMMENTS

Sister Miriam MacGillis, Founder/Director of Genesis Farm, approached the Board and delivered two lengthy written statements. The first one was on behalf of Anna Maria Caldera (of Bangor, PA), who had car trouble, and then she read her own.

The topic was Covanta's announcement to close the Warren County garbage incinerator. They thought this closure could coincide with the implementation of a zero-waste plan, with the cooperation of the Freeholders and the County Recycling Coordinator. Ms. Caldera's comments declared that the expensive, centralized waste processing model is being abandoned worldwide in favor of small, localized separation depots tailored to each community. She detailed the proposed operation, and how it would prevent synergistic toxic effects occurring when household cleaners, etc. are mixed and burned.

Ms. Caldera asserted an increase in area pollution since 1988, including toxic levels of lead and cadmium in the ash; the stream on the property was tested and declared "unfit for human or animal contact or consumption" due to the levels of heavy metals present; the incinerator was one of highest emitters of mercury in the state, with toxic levels occurring in trout in area waters; high levels of sulfur dioxide and carbon monoxide; local increases in asthmas and respiratory illnesses among children; cancer clusters in Oxford; and a 30 percent higher breast cancer rate in Warren County than elsewhere in the state.

Ms. Caldera urged Recycling Coordinator Dave Dech and the Freeholders to consider the sole source aquifer beneath us, and recommend a zero-waste plan.

Sister Miriam MacGillis then read her own comments, urging Warren County to be the first to create a new, proactive Department of Restoration, focusing on restoration of the health of the air, soils, water, farms, people and wildlife of the region. She further suggested a new academic program at Warren County Community College dedicated to the creation of a green future. She offered use of extensive archives at Genesis Farm, and invited the Freeholders, along with any staff and consultants, to visit Genesis Farms to experience various initiatives, including composting toilets, grey-water systems, solar photovoltaic and solar space heating panels, plantings, and more.

Sister MacGillis closed by offering a gift to the Freeholders of original sacred tobacco seeds from indigenous peoples that the farm was able to plant and bring back.

John Nouse of Hardwick Township, who was also a member of the North Warren Board of Education, talked about the challenges the Still Valley Road closure has presented in terms of bussing the students. The sign says, "Road is Closed" as opposed to stating it is closed to through traffic. Buses cannot cross that barrier without incurring liability issues. Mr. Lazorisak was apologetic, but said the County was advised on liability as well, which is why the signage has to

remain the way it is until we believe access is safe. County Counsel Joe Bell said we do not want to exacerbate anything.

Mr. Sarnoski said other ideas, including pumping, were shot down because the property owner denied the County the right of way to pump. He urged more patience.

There were no comments or questions from the press.
