MINUTES APRIL 10, 2019

The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on April 10, 2019 at 7:00 p.m.

The meeting was called to order by Director Sarnoski and upon roll call, the following members were present: Freeholder James Kern, III, Freeholder Richard Gardner and Freeholder Jason Sarnoski. Also attending were County Administrator Alex Lazorisak, County Engineer Bill Gleba, County Counsel Joe Bell and County Fiscal Analyst Kim Francisco.

The Pledge of Allegiance was led by Director Sarnoski.

PROCLAMATION TO DECLARE NATIONAL PUBLIC SAFETY TELECOMMUNICATORS WEEK, APRIL 14 – 20, 2019, WHILE RECOGNIZING 25 YEARS OF OUTSTANDING SERVICE

WHEREAS, emergencies can occur at any time that require the prompt responses of police, fire or emergency medical services that are critical to the protection of life and preservation of property; and

WHEREAS, the safety of our police officers, firefighters and emergency medical personnel is dependent upon our Telecommunicators using their skills to obtain accurate locations and critical information from citizens who contact the Warren County 9-1-1 Communications Center; and

WHEREAS, Warren County Public Safety Telecommunicators therefore act in the capacity of First Responders, serving as the first and most crucial link between citizens in need of assistance and our emergency responders as they provide lifesaving instructions to those in

need; and

WHEREAS, this year marks the 25th Anniversary of the opening of the Warren County Communications Center in November of 1994 to provide 9-1-1 services to the community; and

WHEREAS, during the performance of their jobs, Warren County Public Safety Telecommunicators have for the past 25 years made substantial contributions to the apprehension of criminals, suppression of fires and treatment of patients while ensuring the safety of our responders and by exhibiting compassion, understanding and professionalism to all:

NOW, THEREFORE BE IT RESOLVED, that the Warren County Board of Chosen Freeholders recognizes this milestone of 25 years of service and continues to support and laud Warren County's Telecommunicators as vital, esteemed members of the 9-1-1 Public Safety system and does hereby proclaim April 14-20, 2019 to be National Telecommunicators Week in Warren County in honor of the men and women whose diligence and professionalism keep our County and citizens safe.

Mr. Sarnoski said Public Safety tele communicators are the first contact many have in an emergency. These situations can be very difficult, requiring patience, and they do it with aplomb. "Without you," he said to the Public Safety staffers in attendance, "we'd be in a lot of trouble."

"Thank you," said Mr. Gardner said to the telecommunications team. We never know when we're going to need serious help, he said, and we greatly appreciate your service. He congratulated them on the milestone, and assured them the Freeholders were going to continue to fight the State for the 911 fees that should rightfully go to the counties.

Mr. Kern echoed his colleagues' sentiments, noting this was not a nine-to-five profession. You're there all the time, he said, added that they were the glue that holds all the emergency services in the county together, knowing which responders to send to the scene.

Present to accept the proclamation along with Public Safety Director Frank Wheatley and Deputy Director Bill Hunt were the following: Public Safety Telecommunicator Kaci Buck, Lt. Michelle Warren, Captain Jason Tarsi, Captain Gary Hill, Chief Stephen Howell, and Emergency Management Deputy Coordinator Michael J. Petruzzellis.

Mr. Wheatley thanked the Freeholders for their support. Regarding the 911 fees, he said the State has diverted upwards of two million dollars in funds. Yet the Board has never turned him down for a budget request. "For that, I thank you," said Mr. Wheatley.

PROCLAMATION – ALCOHOL AWARENESS MONTH, APRIL 2019

WHEREAS, since April of 1987, the National Council on Alcoholism and Drug Dependence, Inc. (NCADD) has sponsored Alcohol Awareness Month to increase public awareness and understanding, establish stigma-free communities and encourage local communities to focus on alcohol and alcohol related issues; and

WHEREAS, alcohol is the most widely used substance of abuse in the United States; 15.1 million adults, or one in every forty youth between the ages of 12 -17 suffers from alcohol abuse or dependence; and

WHEREAS, approximately 32% of the population sought treatment for alcohol and substance abuse in Warren County in 2018; and

WHEREAS, alcohol use by young people is extremely dangerous both to themselves and society, and is directly associated with traffic fatalities, violence, suicide, educational failure, alcohol overdose, and other behavioral problems; and

WHEREAS, research has shown that children who have conversations with their parents about the dangers of alcohol and drug use are 50% less likely to use these substances.

WHEREAS, establishing Stigma-Free Communities will raise awareness of resources and encourage residents to engage in treatment as soon as the need is identified so recovery can begin, hope is inspired and tragedies are avoided, and;

WHEREAS, responsibility rests with both public and private sectors for assuring reductions of alcohol and substance abuse related problems and for providing access to treatment for all individuals and family members affected by alcohol and substance abuse.

NOW, THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County of Warren does hereby proclaim the month of April as **ALCOHOL AWARENESS MONTH** and calls upon all citizens, parents, governmental agencies, public and private institutions, businesses, hospitals and schools in Warren County to support efforts to end underage drinking, increase awareness of alcohol use disorders and the success of prevention and treatment.

Mr. Kern thought the statistic regarding 32 percent of the County's population having sought treatment for alcohol and substance abuse in 2018 was "eye-opening". This continues to be a problem, he said, so we should do everything we can to make sure these numbers don't rise. Mr. Kern noted our Human Services Department, and Local Advisory Committee on Alcoholism & Drug Abuse (LACADA), do a great job under the direction of Shawn Buskirk.

Mr. Gardner said this is a problem that affects all of our society. He was especially troubled by substance abuse by young people, and the peer pressure they experience. He said we have a great responsibility to lower these statistics.

Mr. Sarnoski thanked the Human Services Department, LACADA, and the Addiction Awareness Task Force for efforts to combat this problem.

Shawn Buskirk accepted the proclamation on behalf of the Department of Human Services and LACADA. She expressed gratitude to the Freeholders for always being supportive. She said alcohol abuse is still the most pervasive among substances, and the most difficult from

which to withdraw physically. She mentioned some encouraging engagement among Centenary University students on this front.

WHEREAS, the Warren County Board of Chosen Freeholders recognizes the problem of child abuse and neglect and is committed to helping its victims; and

WHEREAS, child abuse hurts children physically, mentally, and emotionally at an immeasurable loss to society; and

WHEREAS, the Court Appointed Special Advocates for Somerset, Hunterdon & Warren Counties (CASA SHaW) recruits, trains, supports and supervises community volunteers as advocates for children who have been removed from their home due to neglect or abuse; and

WHEREAS, CASA ShaW volunteers ensure children's best interest remain the priority while working toward establishing a safe, stable, and permanent home for each child served; and

WHEREAS, CASA SHaW volunteers serve as the court's eyes and ears in a child's life advocating for every child eligible to have a volunteer advocate; and

WHEREAS, this month of April in the year 2019, we honor the professionals, volunteers, and organizations who work tirelessly to protect at-risk children and care for those who have experienced abuse or neglect; and

WHEREAS, April 2019 is National Child Abuse Awareness Month, an observance that reflects the mission of CASA SHaW and the many organizations that seek to improve the lives of children in our community adversely affected by abuse and neglect; and

WHEREAS, the "Go Blue for CASA" campaign is coming to our community, bringing with it support for advocacy for children and to heighten awareness of the plight of the most vulnerable children in our community.

NOW, THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County of Warren does hereby proclaim April as **CHILD ABUSE PREVENTION and GO BLUE for CASA MONTH** in Warren County and call upon all citizens, community agencies, faith groups, medical facilities, and businesses to increase their participation in efforts to prevent child abuse and strengthen our communities and families.

Mr. Gardner said we endorse this proclamation annually, as it should be. Our children are our future leaders. Child abuse is a tragedy that should not exist. It is incumbent upon society to do a better job combating this epidemic.

Mr. Kern concurred, saying children are most vulnerable. An abusive event can affect them for the rest of their lives. He said he fully supported this proclamation, and commended all volunteers working in the field.

Mr. Sarnoski said human trafficking is another angle, noting Sussex County recently passed a similar proclamation regarding how child abuse relates to human trafficking. He thought it was an important lesson, and expected to bring more information to the Board in the future.

Tracey Heisler of CASA SHaW accepted the proclamation, thanking the Freeholders very much for acknowledging this problem. She said in Warren County, about 200 kids end up in foster care due to abuse and neglect. The opioid crisis has only deepened the severity of the cases. She said more volunteers are needed in Warren County to provide an advocate for every child who needs help.

WHEREAS, bicycle tourism is a growing industry in North America, contributing \$47 billion a year to the economies of communities that provide facilities for such tourists; and

WHEREAS, Warren County stands to benefit from this opportunity both economically and from the health and environmental related benefits of encouraging bicycle travel in our region; and

WHEREAS, the American Association of State Highway and Transportation Officials (AASHTO) has designated a corridor crossing New Jersey that follows the Delaware River to be developed as United States Bike Route 1 (USBR 1); and

WHEREAS, the Adventure Cycling Association and the Bike Walk New Jersey, with the cooperation of NJ DOT, have a proposed specific route to be designated as USBR 1; and

WHEREAS, the proposed route for USBR 1 travels through Warren County and can provide benefits to the County; and

WHEREAS, the choice of roads for a US Bicycle Route is a tradeoff between low traffic, direct routing, access to services, access to points of interest, and scenic roads; and

WHEREAS, starting from the north, the proposed route will enter Warren County from Sussex County on Old Mine Road. Continue on Old Mine Road to the I- 80 bicycle/pedestrian bridge and cross over into the State of Pennsylvania. It reenters Warren County via the Riverton PA – Belvidere Bridge. It continues on Water Street and then turns right on Greenwich Street (CR 620). Follow CR 620 and turn right on Foul Rift Road and follow to the intersection with River Road/Roxburg Station Road (County Route 622). Turn right on River Road (CR 622) and continue to the intersection with River Road. Turn right on River Road and continue to the intersection with Brainards Road (CR 621). Continue on River Road (CR 621) into the Town of Phillipsburg utilizing North Main Street and South Main Street (NJ 122). The route follows South Main Street, which includes CR 678, to the intersection with Carpentersville Road. Turn right on Carpenters Road, which the turns into River Road and continue to the intersection with Warren Glen-Riegelsville Road (CR 627). Turn left on CR 627 and then right to continue on CR 627 to where it leaves Warren County and enters Hunterdon County; and

WHEREAS, USBR 1 begins in Bar Harbor, ME and ends in Key West, FL and is already designated in ME. NH, MA, VA, NC, and FL; and

WHEREAS, designating a USBR does not impose any constraints or restrictions on the use of a road, or right-of-way or its future status or use for any other purpose is not changed; and

WHEREAS, there is no requirement that roads for US Bicycle Routes meet the guidelines in the AASTHO Guide for Bicycle Facilities. It is recognized that local "engineering judgment" will determine when a road is suitable for inclusion in a USBR designation; and

WHEREAS, on April 1, 1997, Governor Christine Todd Whitman signed into law Senate Bill No. 560, which had previously been unanimously passed by the Senate and General Assembly of the State of New Jersey; and

WHEREAS, this legislation confers upon each county board of freeholders the authority to designate mosquito commissions or other agencies to provide surveillance, education, training, and recommendations on integrated pest management for the management of Lyme disease or other tick-borne vectors and to provide tick management activities in accordance

with the best management practices and protocols established by the Department of Health;

WHEREAS, the WCMEC has passed a resolution urging the Warren County Board of Chosen Freeholders to so designate the Warren County Mosquito Extermination Commission if funding should become available; and

THEREFORE, BE IT RESOLVED the Warren County Board of Chosen Freeholders to designate WCMEC to provide tick surveillance, education, training, and recommendations on integrated pest management for management of Lyme disease and other tick-borne diseases and to provide appropriate tick management activities if the funding should become available.

County Counsel Joe Bell had a few items for Executive Session relative to litigation and contract negotiations.

County Engineer Bill Gleba had nothing to report.

County Planner Dave Dech talked about the recent "very successful" recycling seminar. The main message was contamination in recycling. Mr. Sarnoski said it did get rather complicated. The hardest part was going to be educating the community regarding acceptable recycling practices.

Mr. Dech noted that he had distributed to the Freeholders' mailboxes for review, a copy of the latest Solid Waste Management Plan as submitted by the Solid Waste Advisory Council. There would be a public hearing on the matter either the last meeting in May or the last meeting in June.

County Fiscal Analyst Kim Francisco said his office had followed up on the concerns raised by Hardwick Township Committeeman Jim Perry regarding the payment in lieu of taxes matter relative to the three municipalities in the Delaware National Recreation Area. He said Mr. Perry was correct, and beginning in 2019 the County will distribute the money as agreed.

County Administrator Alex Lazorisak had the latest vacancy report, about which there were no questions or comments.

Mr. Kern said there would be a guest speaker discussing the Spotted Lantern Fly at the April 22 Planning Board meeting, which he expected to be very interesting.

Regarding the Technology Task Force and its mission, Mr. Kern said a memo had been sent out to department heads seeking input, and there has been some good feedback regarding new technologies and social media. The Fire Academy had requested we host its web page on the County website. That will be considered, as one of the goals is to avoid duplication.

Mr. Kern and Mr. Sarnoski both planned to participate in the April 23 Chamber of Commerce meeting to discuss the Grown in Warren study with different civic and business leaders in the county.

Mr. Gardner mentioned a volunteer luncheon earlier in the day at the Southwest Branch of the Warren County Library. "We can't do it alone," he said, "The volunteers are so significant in

Warren County." It all matters and makes everything work better, he said.

Mr. Sarnoski announced that County Route 659 in Hardwick was now open (one lane, alternating traffic). He thanked the Road Department and Engineering for continuously monitoring the situation.

The Warren County Regional Coalition for Addiction was to have its annual recognition luncheon for those who work to prevent addiction. Mr. Sarnoski and Doug Steinhardt were nominees for recognition this year. He was grateful for the honor, and looked forward to attending.

Closing Public Comments

Bud Allen of White Township said he had attended a White Township Planning Board meeting the night before, and the topic was the potential of six warehouses with 2,500 parking spaces being installed on 600 acres on Route 519. Depending on the nature of the businesses going in there, it could mean a lot of truck traffic on Route 519. Currently, he said, this property was not in a service area for the Municipal Utilities Authority. He expressed concerned regarding vehicular traffic getting in and out of the Brookfield senior development, and the lack of lighting at the entrance. He said he was not against light industry in the area, "But by God it better be done right," he said. Mr. Sarnoski said he was right about the traffic, but the potential creation of a substantial amount of jobs would be a positive angle.

Another item on Mr. Allen's mind was an unfinished building on the highway. He said there is standing water around that building when it rains. He said it has been two years. He thought the County should make them do something to remediate the problem. Mr. Lazorisak suggested he contact the local zoning official to reach out to Soil Conservation.

There were no questions or comments from the press.
