MINUTES APRIL 24, 2019

The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on April 24, 2019 at 7:00 p.m.

The meeting was called to order by Director Sarnoski and upon roll call, the following members were present: Freeholder James Kern, III, Freeholder Richard Gardner and Freeholder Jason Sarnoski. Also attending were County Administrator Alex Lazorisak, County Engineer Bill Gleba, County Counsel Joe Bell and County Fiscal Analyst Kim Francisco.

Director Sarnoski led the Pledge of Allegiance.

The Board welcomed Knowlton resident Linda Brennan and her six-year-old female Labrador retriever, Heart, a team recognized at the very top of their field. For four straight years, Heart has been the Masters Obedience Champion at the prestigious Westminster Kennel Club Dog Show in New York City.

A full-time dog trainer since the year 2000, Ms. Brennan moved to Columbia in 2002. Linda and Heart have won all four years since the Obedience competition was first included at Westminster in 2016.

Mr. Sarnoski said he was very excited to have a dog as a guest, having two dogs of his own that do not listen to him very well. He thought it was great to have a Warren County pet and owner internationally recognized for such amazing feats.

Mr. Gardner said he has had dogs all this life - he happened to be partial to Border Collies – and Ms. Brennan deserved a lot of credit for training her dogs to such a high standard, and for prevailing at a premiere competition.

Mr. Sarnoski said corrections professionals deal with challenging people that may be at their worst. Bail reform legislation has added more rules and regulations that potentially make their jobs even more demanding, but they handle difficulties with a high level of professionalism. Mr. Sarnoski said he appreciated our corrections employees, and thanked them very much.

Mr. Gardner felt that he couldn't say enough good things about corrections professionals. He mentioned having taken a leadership course about 20 years ago, which included a tour of Camden County's correctional facility, that he found rather eye opening. He had toured our own correctional center when he first became Freeholder. He said corrections officers must have an enormous amount of patience. Upon release, he hoped for inmates to be able to become productive citizens. Mr. Gardner said Warden Ken McCarthy and his staff run the facility "the right way".

Mr. Kern noted the importance of remembering that this is a 24-hour facility. Staff there are constantly dealing with some difficult situations, and society often doesn't pay the proper respect to this area of law enforcement. He said it takes a special person, and a lot of courage, to work in this field.

Warden Ken McCarthy said his background was in law enforcement; he was fairly new to the field of corrections. Since being assigned to the Correctional Center, he said he has gained a lot of respect for what is an often forgotten part of law enforcement.

Accompanying him to receive the proclamation were Officer Dan Twist, Sgt. Nichua Liaci, Lt. Robert Garatty, Jr. and Cpl. Bob Bevins. "I think they do a phenomenal job over at the jail," said Mr. McCarthy, "They work in a thankless atmosphere for people that don't always appreciate what they're doing." He appreciated the Freeholders recognizing the Corrections Department.

REPORTS AND COMMENTS

County Counsel Joe Bell said he had two matters regarding litigation for discussion in Executive Session.

County Engineer Bill Gleba reported on two items that appeared on this evening's agenda: the Point Mountain Road Bridge is now complete and open; but two overweight truck incidents on Rymon Road over the Musconetcong River have resulted in the structure's closing in the interest of public safety, for a time yet to be determined.

Mr. Sarnoski inquired about updates on Spring Valley Road. Mr. Lazorisak said it is still open as a single lane, but found it encouraging that even with all the rain recently, the water receded a bit due to the warmer temperatures. "There was heaving throughout; we're certainly going to have to do repairs," said Mr. Lazorisak.

County Planner Dave Dech took the opportunity to promote the Paper Shredding event on May 4, as well as Household Hazardous Waste Collection at the landfill on April 28.

Mr. Dech also reported having received a draft of the capital construction program from the NJ DOT, and he was not pleased to report that the Route 57/519 project has been delayed another two years. He said they are having a meeting on May 7 with DOT to try to get to the bottom of it.

County CFO Kim Francisco said the audit report had been delivered earlier in the week. It was a clean audit and a very good report with no recommendations.

He advised the Board of an internal transfer of funds from our unemployment trust account, which has excess funds, to our health insurance trust, as the County is going to self-insurance.

County Administrator Alex Lazorisak had the latest vacancy report, which contained nothing out of the ordinary, and issued a reminder that the Board's May 8 meeting had been cancelled due to the NJAC Annual Conference conflict. The next meeting, on May 22, will start at 7:30 p.m.

FREEHOLDER COMMENTS

Mr. Kern talked about having attended a Chamber event the previous evening, along with Mr. Sarnoski, that he thought was very well attended and offered some good information. The

group heard from Congressman Tom Malinowski, as well as several mayors. He said there is a lot of good stuff going on in our area, which was very positive.

Regarding the high level of interest in the threat of the Spotted Lantern Fly, particularly among Planning Board members, Mr. Kern said he had conversed with Dave Dech regarding possibly creating a working group comprised of experts to study the issue and report to the Freeholders.

Mr. Gardner lamented the lack of leadership at the State level. Pennsylvania has been very proactive, but he thought our own Department of Agriculture needed a push to become more engaged.

Mr. Sarnoski suggested the County Administrator consider the matter with Mr. Dech to determine the best plan of action. He thought perhaps a more holistic approach was warranted, as the Spotted Lantern Fly is not the only threatening insect species out there. He agreed the State should take more of a leading role.

In agreement that the State should take the lead, Mr. Lazorisak added that if the Planning Board is going to get involved, it should join forces with the Shade Tree Commission. This commission has also had open dialog on these issues, and has a good connection with what is happening on the State level.

Mr. Gardner noted the threat of imported materials, as that is how most of these pests arrive, and hoped the State could ramp up USDA inspections if warranted.

Concluding his remarks, Mr. Kern mentioned a Stigma-Free Community event happening in Washington Borough on April 27. Mr. Sarnoski said it was fantastic to see the Stigma-Free initiative moving along so nicely.

Mr. Gardner looked forward to the NJAC Annual Conference, hoping for high attendance, as it is an excellent, informative, educational conference.

He then referred to a draft document he had distributed to others on the dais in reference to the NJ DEP proposing dry-run streams returning to watercourses, particularly affecting the Pequest area. When the Highlands legislation was passed, he said, the regions outside the Preservation Area were to be left alone. He found the timing curious, as the DEP just finished removing the dam from the Pequest, and now they want all these little tributaries. He thought this was an outrage, as there was no call to do this, and people will not be able to do anything on their properties within 300 feet on either side of these streams.

Mr. Dech said comments are due May 3 to the DEP. Mr. Sarnoski said he would read the draft comments and provide any recommendations. Mr. Kern asked if the municipalities knew about this. Mr. Dech wasn't sure because he said he found out about it by accident. "Not much time to educate and get comments from municipalities," said Mr. Sarnoski. The Freeholders thought it was worth pursuing asking for an extension to the deadline for comments.

Mr. Sarnoski reiterated a few announcements for his comments: the Board's next

meeting was cancelled due to the NJAC Conference, and the meeting after that will begin at 7:30 p.m. He complimented Mr. Kern for doing a great job at the Chamber meeting, reporting on the Grown in Warren initiative.

CLOSING PUBLIC COMMENTS

Joanie Ashoff of Buckhorn Drive, Belvidere, came forward to express concerns about the proposed Jaindl project - a preliminary plan for 585 acres of farmland to be utilized for warehousing, and has the potential for seven industrial buildings totaling more than 6 million square feet. While in its infancy, as a formal application has yet to be filed, Ms. Ashoff had some questions about transparency when the application is filed.

Mr. Sarnoski pointed out that the Mayor of White Township was in the audience, if he was willing to talk about it, but "the County doesn't have much of a say in this process," he said. Mr. Lazorisak clarified that zoning is governed by the local municipality. The plan will be presented in front of the White Township Planning Board, "and that is the meeting to attend," he said. "This Board has no say regarding that application whatsoever," said Mr. Lazorisak.

Ms. Ashoff said County Route 519 will be involved. At that point, said Mr. Lazorisak, Jaindl will apply to the County Planning Board. The potential impacts to Route 519 will be studied then. "But when it comes to the particular use of that property, that all falls in the hands of White Township," Mr. Lazorisak reiterated. "This Board has no say on the use."

Ms. Ashoff wanted to know if the public could address the local Planning Board on the issue, even before an application is filed. She was told that was up to the local governing body, which is required to publicize its agenda to the public.

Ms. Ashoff continued to ask questions about the notification process, wondering if those affected would receive letters in the mail. County Counsel Joe Bell said possibly, to those whose properties are located within 200 feet of the development. He suggested keeping in contact with the local Planning Board Clerk to keep apprised of developments. Ms. Ashoff said she appreciated the Freeholders listening. "People are very, very concerned... this is going to impact our area tremendously and will change everything," she said.

Lorraine Klein of White Township introduced herself, saying she resided directly next to this project. Her opinion was that the Freeholders have a great deal of influence. We need help, she said.

Nancy Mason of Belvidere said the Board was speaking earlier about invasive insects. Another plague is warehouse development, she said, bringing tractor-trailers up and down County roads. She understood it was a local issue, but said it will affect the entire county. She asked them to consider the intersection of Routes 519 & 57 and the nearby underpass being insufficient for large trucks, as well as other roads that will have to endure heavier truck traffic.

Ryan McDonald of Liberty Township approached the Board regarding Sussex County having taken action to include a non-sanctuary county referendum on an upcoming ballot, and requested Warren County do the same, hoping to see it on the next meeting's agenda. He also

said he had a recall petition for Governor Murphy and would be out in the parking lot after the meeting to collect signatures.

Regarding the sanctuary matter, Mr. Kern said he felt he and his fellow Freeholders support the rule of federal law, and will follow it, working with different government agencies as allowed. He said there have been some issues with respect to New Jersey, with a new directive from our Governor and Attorney General. He invited Warden McCarthy to elaborate on how the directive affects Warren County.

Mr. McCarthy said the directive limits law enforcement in dealing with ICE (Immigration and Customs Enforcement) on immigration law. "As far as corrections is concerned, it has kind of enabled us in one respect, and limited us in another respect," he said. The Correctional Center does have a working relationship with ICE, dealing with the Newark office on a regular basis. Warren County does not have the volume of people involved with ICE issues as in other areas of the state, but we do have instances of people that are of interest to ICE being arrested in Warren County.

The new Attorney General's directive, which we are mandated to follow, allows ICE to contact the Warren County Jail to express interest in talking to an inmate. Prior to this directive, Mr. McCarthy said, ICE could come to the jail and enter an interview room with the inmate, who could talk to them or not. Now, we have to approach that inmate with options: talk to ICE freely, talk to them with an attorney present, or not talk to them at all, and complete a form indicating preference.

Another change is that the jail can hold an inmate being released on a criminal charge up until 11:59 p.m. that evening, for ICE to come pick them up. In the past, ICE was only given a two to three-hour window.

Mr. Sarnoski said in his opinion, he did not believe Warren County should be a sanctuary county. "I encourage all of our department heads to work, and comply completely with, our federal agencies to obey the laws of the federal government and our state government," he said. His concern with passing a resolution similar to Sussex was that a referendum does not have any legal impact. He said a resolution by this Board is just as strong as a resolution passed by the residents of Warren County stating that they do not want to be a sanctuary county.

County Counsel Joe Bell spoke a bit about the law and procedure, concluding that referendums are normally pursued for something more within our purview, such as a bond measure for improvements to the County College or Vocational School. "I think when you get into the area of sanctuary cities and things of that nature, it may be outside the bounds of what we can do pursuant to the statute," he said.

Mr. Sarnoski added that costs are incurred with a ballot referendum. He preferred not to pursue a path that costs money, when the Freeholder Board can have the same impact by passing a resolution. He thought that more appropriate and efficient.

Mr. Kern noted additional financial impacts, saying that the State of New Jersey is in a

difficult position in terms of receiving federal grants, for failing to comply with federal law.

Mr. Gardner said true citizens, the home base taxpayers, must be considered first.

Domenica R. of Harmony Township returned to the Jaindl topic. Acknowledging the Board's admonition that this is a local issue, she said, "You are here for us as residents, and for Warren County... this is going to destroy this area of Warren County, and it needs to seriously be looked at." She predicted the truck traffic would be "absurd".

Mr. Sarnoski assured her that it is not that the Freeholders do not care about the impact this may have on Warren County and the roads, but they will take every legal, correct measure within their purview to make sure everything is done properly. He assured her that when the County Engineer does receive an application for this project, the County will seek a traffic impact study and any other appropriate information. "That's how we have our say in this," said Mr. Sarnoski.

Mr. Kern said he thought the citizens were the most powerful people in this scenario. He advised them to organize and go to those local meetings to make their voices heard. Resistance from the community may have an impact on the applicant's plans.

Debbie of Harmony Township said she travels Route 519 every day and has two young drivers. She asked the Board to consider all the kids along Route 519 waiting for school buses in the morning.

Donna Bevington of Belvidere said this is not only a current issue; this is going to be forever. She said it will cost Warren County a tremendous amount of money to keep Route 519 in good shape once the truck traffic comes in.

Theresa Chapman of Harmony Township wondered about the impact on emergency services. Public Safety Director Frank Wheatley said White Township is served by mutual aid through other municipalities (Harmony, Belvidere, Liberty and Oxford), not by the County.

Todd Cook of Hope Township asked who would do the traffic impact study. Mr. Gleba said it would be the applicant. Mr. Cook thought it likely the study would favor Jaindl in that case. Mr. Bell said the analysis would be cross-examined at the local level. If the board is not happy with the statistics provided at the hearing, the board itself can require, and hire, its own independent traffic analysis study.

There we no further public comments, nor questions from the press.
