Mr. Sarnoski echoed Mr. Gardner's sentiments and also mentioned Mr. Jim Sheldon was a great member who served on the Economic Development Committee but had to resign. He thanked everyone else as well.

REPORTS AND COMMENTS

MINUTES JULY 24, 2019

County Counsel Joe Bell stated this evening there will be a brief status on certain litigation involving the County W.M./R.M./C.C. and the discussion on landlord tenant issue and Court Room 2.

County Engineer William Gleba stated the long anticipated water main extension program for the Pohatcong Valley Ground Water Contamination project is underway. They are going to pave Spring Valley Road/ County Route 659 tomorrow, Thursday July 25 as the weather seems to be cooperating. On July 12, he took some measurements, the water was receding back down to the levels it was back in April when the road was reopened. Mr. Lazorisak mentioned the Supervisor of the Road Department stated today its 5 inches higher in elevation after the storm. Mr. Sarnoski noted we have had significant rain and it's now and lake and will be a significant challenge.

County Planner Mr. Dech mentioned the North Jersey Transportation Planning Authority released its drafts for 2020 and 2023 Transportation Improvement Program which includes Route 57/County Route 519 project and the Route 80 Rock Fault project as well. If ok, he will draft comments regarding those two projects. Mr. Sarnoski asked he put together comments so we can get to the municipalities who have interest. Mr. Sarnoski mentioned that Knowlton might want to attend the NJTPA meeting when those projects come to a vote. Mr. Sarnoski also noted the Freeholders have sent letters of displeasure for the delay with the Route 57/County Route 519 project and that the cost is too high for the rock fault. Mr. Gardner asked if the state is going to hold a meeting regarding rock fault. Mr. Dech stated maybe one more scheduled a year from now.

County CFO had nothing to report.

County Administrator Alex Lazorisak had the latest Vacancy Report for review and approval, saying it contained nothing unusual. The County received the FEMA reimbursement for the 2016 Winter Storm Jonas in the amount of \$296,000.

FREEHOLDER COMMENTS

Mr. Gardner mentioned that the Warren County Farmers' Fair starts this Saturday and how it's a great county fair. Please take the time to go.

Mr. Sarnoski stated there is no meeting in the second week of August. The next meeting is the 4^{th} week in August. During the public comments, Mr. Sarnoski mentioned that there is a significant fall in the OPOID overdose deaths in the 1^{st} 6 months of the year in Warren County. He attributes the success to the prosecutors, the police departments and the use of narcan.

PUBLIC COMMENTS

Reggie Regrut from Phillipsburg mentioned we have a lot of farmers in Warren County. A lot of the farmers are illegal aliens. Our county needs illegal aliens.

Stuart and Elizabeth Ridley from Phillipsburg mentioned Stuart is an immigrant. It's not easy to

become a legal citizen, it's hard to get things done. Elizabeth stated immigrants are not a danger and are wonderful people.

Iris Perrot from Port Murray mentioned NJ is not a sanctuary state. She stated the resolution potentially proposed would put law enforcement in danger. Mr. Sarnoski stated we don't have a resolution to comment on.

Brian Cameron from Lodi mentioned illegal immigration is a drain on our whole society. They are not paying taxes, social security and others.

Carolyn Cerbone from Belvidere mentioned NJ is not a sanctuary state. Asked that we not pass or write any resolutions as we are not a sanctuary state.

Aaron Hyndman from Hackettstown is a Vice Chair of the Mental Health Board wanted to discuss the proposal for anti-sanctuary resolution. Personally, it would be a detrimental effect to mental health issues and our First Responders. Again, NJ is not a sanctuary state. He would like the Freeholders to reconsider passing any anti-sanctuary resolutions.

Megan Davis is from Hackettstown asked that the Freeholders table any resolutions regarding antisanctuary. She stated this possible resolution would affect relationship with local law enforcement. Children would be in fear and consider the most vulnerable people in your decision.

Daniel Walton from Independence and has visited a lot of countries and immigrants are mostly good, trustworthy people. They just want to live the American dream.

Kelly Shea from Hackettstown echo remarks regarding immigrants. Stated we should have a path to citizenship for immigrants already here. Agriculture is highly relied upon by immigrants to hand pick in NJ. We can't alienate immigrants.

Donna from Belvidere asked if we have had a meeting with a developer. Mr. Lazorisak stated we had a meeting with Jaindl, County Counsel, Engineering and Planning. Jaindl presented the plans that were sent to White Township. Mr. Sarnoski stated we told them how to do the application process and nothing will be discussed without an application. Donna asked if there is an escrow account for this. County Engineer stated the mitigation measures during the application might involve a financial nature.

Harold VanSeters from Harmony lives on Harmony Hill and lives in fear on that hill. Traffic is dangerous and there has been multiple accidents. He asked we take a look at what the proposed developer would do to the traffic on County Route 519 if more traffic comes through.
