

These minutes were approved by the Board of County Commissioners on May 10, 2023. Full texts of resolutions appear at the end of this document.

The Board of County Commissioners of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on March 22, 2023 at 6:00 p.m.

The meeting was called to order by Director Ciesla and upon roll call, the following members were present: Commissioner Jason Sarnoski, Commissioner Deputy Director James Kern III and Commissioner Director Lori Ciesla. Also attending were County Administrator Alex Lazorisak, Assistant County Counsel Joe Bell IV, County CFO Kim Francisco and County Engineer Bill Gleba. Deputy Commissioner Clerk Tracy Matlock was absent.

After leading the flag salute, Ms. Ciesla confirmed with the County Administrator that notice of this meeting was in accordance with the Open Public Meetings Act, Chapter 231, P.L. 1975.

Approval of Minutes

County CFO Kim Francisco explained the reason for the resolution is to build up a cap bank. He said the State allows us to increase our budget levy by 2.5 percent this year, but we could go as high as 3.5 percent by resolution. What we don't use, we can bank for the next two years.

County CFO Kim Francisco discussed the budget briefly and made mention the county tax rate equalization will decrease 4.5 cents this year. He said like home, some of the County’s expenses have gone up. Most department heads were able to hold the line. Mr. Francisco pointed out the health insurance costs remained flat because a few years ago, the County left the State Health Care Benefits Plan. The State plan is increasing on an average of 19 percent. If the County were still in that plan, there would be an increase of \$2.7 million.

County CFO Kim Francisco noted this is a much smaller budget. The levy will be flat and the library rate will go down half a cent from 5 cents to 4.5 cents. He made mention we are a “pay as you go” County, so we have been saving for the renovation of the CDH Library in Blairstown as well as some painting at the Northeast Branch and these projects will be starting soon.

Liza Thomas, Liberty Township, raised concerns about particular books she believes should be taken out of general circulation and asked if the money to the library can be withheld until these books are put into a different type of circulation or something is done differently with them. She stressed she is not looking at banning the books. It was discussed how the library’s budget is a statutory requirement for the State, so the money cannot be withheld.

County CFO Kim Francisco started by saying these projects are fully funded, so there will be no borrowing of moneys. Capital projects for this year will include resurfacing, road improvements, equipment and technology, voting machine replacement, security upgrades at the County Jail, radios for Prosecutor, and upgrades at the Office of Emergency Management, the continuation of asbestos removal at the Courthouse, conversion of oil heat to natural gas at some facilities, installation of EV charging stations, and a contribution to Warren County Vo-Tech for their capital needs, new vehicles and equipment, renovations at the CDH Library, addition to the Human Services building. The total cost of the Capital Improvement budget is \$15 million dollars, again, it's fully funded and we're leaving \$4.6 million dollars in the Capital Improvement Fund.

Mr. Sarnoski emphasized the American Rescue funds have to be allocated within the next two years in order to be spent. We have \$20 million and have allocated \$8 million this year.

Ms. Ciesla commented on what a great system is in place here. She agreed with Mr. Sarnoski about being in a position to use American Rescue funds to do what we need to do.

Mr. Francisco explained this is the official adoption of the budget. The total budget is \$106 million with a tax levy of \$75.5 million.

Mr. Sarnoski commented we are spending overall 10% less than we did when he first ran for Commissioner back in 2010. We are spending less than thirteen years ago on government services. This board recognizes that what we ask for from our residents is sacred. It's their hard, earned money and they have a right to it. We only use what we need. He's proud that our tax rate is going up significantly. People want to live, raise families and work in Warren County and people want to bring their businesses to Warren County. It's a safe, beautiful county with a lot of open space. We are seeing a 10.4% increase in our ratables. We are taking that increase in ratables and giving it back to the tax payer which is why we have a 5 cent tax rate reduction. He gave the example of a home that is valued at \$300,000 will have a tax savings of \$150.00. The tax rate today is lower than when he started in 2011. He complimented the whole team on really great work to continue to hold the line on taxes and also to continue to be responsible to the tax payers. The residents thank you and the towns who are suffering thank you, and he thanks you.

Mr. Kern commented what's important about this budget is the work and also what we ask the County departments, the people who everyday serve the residents and tax payers of Warren County. This is an important part of the year where we set the charge, the monetary policies, and we don't make it easy on the departments but that's because we are charged with protecting the tax payers' money. We want to make sure that money is well used. Our departments should be commended for what we ask them to do every year. He believes we provide excellent service to the residents. He's happy to support the budget and appreciates the work done by the Director, Mr. Francisco and Mr. Lazorisak. It's a good budget.

Ms. Ciesla expressed it has been the tough decisions in the past that got us to where we are today. It's a sustainable budget. She echoed Mr. Sarnoski's comments about people wanting to move to and live in Warren County. We always look at this as the tax payers' money and we want to spend it wisely to make sure you get the most out of it. She thanked all the department heads, the CFO and County Administrator who worked hard to get this done. Thank you everyone.

Mr. Sarnoski commented he echoes the concerns mentioned earlier about the books in the library. He has been addressing the issue and will speak to it at the end of the meeting. As far as the library tax, we are holding the levy flat on the tax this year. There is no increase to the library this year. As a statutory necessity we have to pass the budget in order to have the library. He will support this budget.

Ms. Ciesla thanked the staff of the County for their hard work on the budget and for being able to maintain it.

He also reminded the Board of the upcoming WC Technical School Board of School Estimate meeting on April 5, 2023 at 5:00 pm. at the Wayne Dumont, Jr. Administration Building.

Lastly, Mr. Lazorisak discussed the Commissioner's meeting of April 26, 2023 we will not have a quorum. The Board agreed to cancel the regular meeting of April 26, 2023, on a motion by Mr. Sarnoski, seconded by Mr. Kern. Roll Call: Mr. Sarnoski yes, Mr. Kern yes, Ms. Ciesla yes. Motioned carried.

COMMISSIONER COMMENTS

He next turned to the topic of Tiktok and said Warren County has been well ahead of the curve by banning it from all County devices since July 9, 2020. The State of New Jersey didn't ban it until January 9, 2023. He commended Bob Sidie and the IT Department, for being way ahead of this.

Mr. Kern has been working with the parks department to put money in outdoor recreation because there has been such a high demand since COVID. He discussed Merrill Creek Reservoir's change in hours, effective March 1 to October 31, the hours will be open 7:00 a.m. and closing at 5:30 p.m. Mr. Kern will be discussing the change with Merrill Creek.

Ms. Ciesla attended the Bicentennial meeting on March 21, 2023. There is a kick-off, summer concert planned for July 22, 2023, 2:00 p.m. with the Yankee Brass

Band. They will be performing at Garret D. Wall Park in Belvidere, all are welcome to attend.

Next, Ms. Ciesla thanked Art Charlton, Christopher Infinito, and her fellow Commissioners for their assistance in getting a press release out on Broadband. She anticipates a resolution on the next meeting regarding getting more monies to Warren County for the Broadband. The monies are coming to state, now we need monies to be dispersed to Warren County.

Ms. Ciesla noted National Agriculture Day was March 21, 2023. Warren County has preserved 326 farms and approximate 28,000 acres.

Ms. Ciesla attended the Agriculture Legislative Dinner on March 15, 2023, everyone is working together to keep our agricultural businesses thriving.

CLOSING PUBLIC COMMENTS

Donny Ippolito, White Township, came before the Board requesting information on who is responsible for the electric on Brass Castle Road, along with the request of speed sign. Mr. Ippolito also expressed his thanks for the cleanup of the litter on Brass Castle Road. The Board authorized Mr. Lazorisak to speak with the JCP&L representative for Warren County. Mr. Gleba will discuss the request of speed sign.

Mr. Ippolito also questioned who is responsible/authorized for the disposal of books in the library. He feels we are disposing books that should be kept, such as history books, and keep one that shouldn't be distributed.

Liza Thomas, Liberty Township – Continued her concerns about the distribution of certain materials at the library to children. She has been making people aware of what materials the library has that she feels are inappropriate. She commented that people are aware of the form to complete if they have concerns about particular materials, however, people are afraid to attach their names to it.

Tara Mezzanotte, Knowlton Township, I-80 DWG Coalition – Ms. Mezzanotte gave an update regarding the onsite visit of the I-80 with Congressman Kean, Jr. and New Jersey and Pennsylvania Representatives. The Board thanked Ms. Mezzanotte for her organizing the site visit, and also thanked Congressman Kean in taking an active role and participating with this issue.

Mayor Chris Jacksic, Hardwick Township – Mayor Jacksic came before the Board to discuss the issues of County Route 659, Spring Valley Road.

The Mayor also addressed concerns he has with the sale of the Hardwick House and site plans that are coming for development. He had also has concerns for the five (5) camps in the township that will be affected.

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a county may, when authorized by resolution, appropriate the difference between the amount of its actual county tax levy and the 3.5% percentage rate, subject to certain exceptions, as an exception to its final county tax levies in either of the next two succeeding years; and,

WHEREAS, the Board of County Commissioners of the County of Warren finds it advisable and necessary to increase its CY 2023 budget by up to 3.5%, subject to certain exceptions, over the previous year's final county tax levy, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Board of County Commissioners hereby determines that a one percent increase in the budget for said year, amounting to \$ **595,941** in excess of the increase in final county tax levy otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Board of County Commissioners hereby determines that any amount authorized herein above that is not levied, as part of the final budget shall be retained as an exception to final county tax levy in either of the next two succeeding years.

1. The Warren County Sheriff's Office is hereby authorized to exercise the discretion to hire entry-level Sheriff's Officers, exempt from the civil service examination requirement, pursuant to L. 2021, c. 406.

Unless otherwise provided by law or collective bargaining unit agreements, immediate relatives shall not be promoted, assigned or transferred to a regular full-time or regular part-time position where:

- One relative would have the authority to appoint, remove, discipline, evaluate or directly supervise the work or employment of another relative;
- One relative would be responsible for auditing the work of the other; or

- Other circumstances exist which place the relatives in a situation of actual or reasonably foreseeable conflict between the Employer's interest and their own.

Employees who marry or become related by marriage may continue in their employment if the marriage does not result in the creation of a prohibited relationship. Where the marriage results in the creation of a prohibited relationship, the Employer will explore potential accommodations including the reassignment of one or both employees to available positions for which the employees are qualified.

For purposes of this policy, immediate relative includes spouse or significant other, child, stepchild, parent, stepparent, sibling, grandparent, daughter-in-law, son-in-law, grandchildren, or any person with whom the employee has an intimate or dating relationship.

Applicability:

This policy applies to all Warren County Sheriff's Officers hired, promoted, transferred, or assigned on or after the date of adoption and to all prohibited relationships created on or after the date of adoption.
