The Board of County Commissioners of the County of Warren met in Reorganization Session in Court Room #1 at the Warren County Courthouse, Belvidere, New Jersey on January 1, 2024 at 12:00 p.m.

County Administrator/Clerk of the Board Alex Lazorisak opened the meeting at 12:08 p.m.

Deputy Clerk Tracy Matlock read the following OPEN PUBLIC MEETINGS ACT (Open Public Meetings Act, Chapter 231, P.L. 1975) statement: ADEQUATE NOTICE OF THIS MEETING OF *JANUARY 1, 2024* WAS GIVEN IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT OF 1975.

The Invocation was led by Senator Douglas J. Steinhardt, who greeted everyone and stated we are here today in the spirit of unity, progress and for the perpetuation of our country's wellbeing and the country's constitutional republic, where the stories of a rich and vibrant community once steeped in potential. He reminded the Board they are not just administrators but also facilitators, initiators and innovators. He told them their actions today will shape the future. He instructed them to draw upon their collective wisdom, shared vision, and unwavering commitment to serve our community. May their deliberations be guided by understanding decisions by wisdom and action by the spirit of service. May they not forget we are here to serve, uplift, and inspire. May your actions today echo in the generations to come. Let us rise to the occasion, embrace the challenges, and celebrate the opportunities ahead. Together we can make our county and country better places to live, work and thrive. He ended by wishing everyone a happy new year, wished all good luck and good health.

Mr. Lazorisak led the Pledge of Allegiance to the flag.

Certification of Election of Lori Ciesla, Commissioner: Read by Holly Mackey, Warren County Clerk.

The Oath of Office of County Commissioner was administered to Lori Ciesla by Assemblyman John DiMaio. Ms. Ciesla was accompanied by her husband Jim, and son, Nick.

Ms. Ciesla thanked her family for coming with her today and especially during an election season. She acknowledged her friends for keeping her sane, even if that means a crazy day trip.

Ms. Ciesla thanked State Senator Doug Steinhardt, Assemblymen John DiMaio and Pete Peterson, constitutional officers who are here today: County Clerk Holly Mackey, Surrogate Michael Doherty, Sheriff Jim McDonald, who is not here, Prosecutor Jim Pfeiffer and everyone here supporting her and our county whenever possible. She continued to thank Congressman Kean, who could not be here today, but his support for her and fellow Commissioners in our county, is greatly

appreciated. She also thanked Doug as Chairman, Vice-Chair Nancy Brown, Jody Inscho, Secretary, Chris Allen, Executive Director, and all members of the Republican Committee for their unwavering commitment to her community. She joked she loves elections but loves them more when she is not a candidate. She also thanked everyone for their patience with her and she thanked some of those who ran with her this year, especially Randy Piazza and Christopher Infinito who helped her to put up a few of signs.

Ms. Ciesla also thanked all the county employees and volunteers whose hard work makes her look good. Your efforts to help and take care of our residents does not go unnoticed. Led by our Administrator Alex Lazorisak and our amazing department heads, this county is indeed the best county in New Jersey. She gave credit to the many Freeholders who came before her, including current Commissioners Jim Kern and Jason Sarnoski. She thanked the two of them for putting their faith in her to lead the board last year and she commented she thinks she managed to run the meetings well, even if she didn't beat Commissioner Kern's fastest meeting record. She diligently signed the one-hundred million pieces of papers that the director must sign, commenting even when she had to run back to the administrator's office the day after a meeting to sign those she missed the night before.

She said she and the current Commissioners make a great team. Even when they do occasionally disagree, they do it professionally and practically and they all share the same goal: to keep this county at its best and to provide you with what you need in a streamlined, fiscally responsible manner. She said she is blessed to be able to sit up here with Jim and Jason for another three years. She thanked those who voted for her. She is humbled by your trust and she will continue to work hard for everyone in this county.

Ms. Ciesla continued, three years ago today, she stared out to an empty room, thanks to COVID, and she gave her first acceptance speech. She didn't know what to expect but she did know the county was run well. She has since learned that it's run better than she thought. Those who came before her did a fantastic job of making this county an excellent example of how much you can do when you keep government small. This is a huge feat in the state of New Jersey, where red tape, bulging budgets in nonsensical over burdensome regulations rule the day. She said all three commissioners like to get things done. They bring a corporate mindset to the enigma that is government and they treat your tax dollars like they should, as precious commodities that do not grow on trees. They do their best to stay in their lane and keep that lane well paved and maintained. They may have different opinions on many issues, but when they do insert themselves into political hot topics, they do so with an eye toward being practical and logical advocates for residents as well as for our constitution. Our advocacy for issues or against others often comes from our deep seated patriotic love of the best country in the world. To protect and provide for you, we will fight for you here, in Trenton, and in Washington, D.C. She quoted Walt Disney, "Times and conditions change so rapidly that we must keep our aim constantly focused on the future." Here in Warren County, we want your future to be the best possible. We want to enhance our technological and communication needs, which we are doing with the N.J. B.P.U. and others. We'll continue to look at every way possible to keep our county roads safe for all who travel them. She remarked we will support our existing businesses and agricultural communities and also for growth that protects and enhances our history and rural character. She said we've done a lot and we'll continue to do whatever we can for you. She asked the audience if they want to know all the Board is doing, if so, sign up for the new monthly email newsletter, our newest avenue of communicating with our residents. If you want to keep up to date

on Commissioner meetings, we have calendars for you. Our pay as you go methodology has allowed us to improve buildings such the courthouse we are in right now, and build new buildings without incurring a debt burden to our taxpayers. The plans are ready for the New Department of Human Services building and construction has begun on the Catherine Dickson Hoffman branch of our amazing county library system. A big event on the horizon that will help us promote Warren County, our towns, and our businesses across the state, is our upcoming bicentennial celebration. In 2025 Warren County will be 200 years old and we are looking to highlight not only our history, but our present and our future and we have a lot planned. Right after that our beautiful country will be celebrating her semiquincentennial birthday, her two hundred fiftieth and to show you just how young a commissioner board we are, I was the only one alive during the bicentennial in 1976. Our county was named after Joseph Warren, a great patriot from the Revolutionary War. We are looking forward to actively participating in the semiquincentennial celebration.

Ms. Ciesla continued she knows we have challenges ahead too and she said we'll meet those head-on and do all we can to do what is best for our county. Halfway through this year, a storm came through and literally ripped our roads in half. Our small but strong county rallied through but it also became a learning experience for us. We have left no stone unturned in our quest to rebuild and rebuild better. We will always do this no matter what comes our way. She said she does not pretend to know all the answers because that is not how we learn and grow. She will always ask the questions and help find those answers for our county. She continued on by saying always remember that she is here to listen to your ideas and suggestions, and she looks forward to working with everyone during the next three years. Mr. Kern started off with a joke about how he was going to try to run the quickest reorganization meeting. He thanked everyone for attending today. He thanked his colleagues for this great honor. He commented Ms. Ciesla was being a little humble. The storm that came through our county last year was catastrophic that this county has ever seen. Ms. Ciesla stepped up to the plate. Our legislators, Senator Steinhardt, Assemblyman DiMaio, and Assemblyman Peterson were on the ground making phone calls to the Governor's office. Mr. Kern said he is grateful to have Ms. Ciesla's leadership from last year and that of our legislators. He's hoping we have nothing like that this year. He thanked his friends and family, Carina for holding the Bible for him. Mr. Kern announced his engagement.

Mr. Kern spoke of his plans for the year. He's going to continue the work of passed boards of fiscal responsibility from our commitment to the tax payers is paramount. We'll work to provide the most responsible budget for all of you. Our efforts of dedication of fiscal prudence concerning our financial resources on used judiciously, we'll continue and every expenditure will be scrutinized.

Mr. Kern discussed what he would like to accomplish this year. He is committed to the board's focusing on the problems that our county government can solve. New Jersey charges county government with certain powers and it's important that we engage in these spaces in our offices to positively impact them. This year he would like to adjust a few that he hopes we can tackle. First, improving communications for our first responders. Warren County is responsible for 911 communications for all local agencies and we need to commit to providing a long-term solution that allows our police, fire and EMS to communicate seamlessly. While he understands the county's terrain and topography can make this difficult, he said we must do all we can to ensure our first responders safety. This investment will empower our many county agencies with the tools they need to respond swiftly, safely and effectively enhancing public safety for both our first responders and general public at large. He mentioned a meeting is scheduled this week and he is hoping to hit the ground running.

Mr. Kern continued with his second goal which is preserving farmland, which will continue to be a priority of this board. The farming community stands as a testament to our agri-ag area roots and commitment to sustain local agriculture. We must continue to target farms for preservation and advocate for fair compensation by preserving these vital parcels. We'll not only preserve our heritage, but also foster economic resilience within our farming community. Within this space, we'll be announcing in the coming days our Grapes and Grains Tour, partnering with our local vineyards and breweries and new tourism initiatives and promote some of our strongest businesses in the county. In acknowledgement of his environmental responsibilities, this year we will be announcing the commissioner's conservation in partnership with the National Wildlife Federation. Warren County will seek to be the first certified wildlife habitat in the state of New Jersey. We will be working with each of our twenty-two municipalities to create wildlife habitats for insects, birds, and amphibians both locally and long migratory corridors. This initiative relies on our commitment to ecological sustainability and ensuring our natural space is to thrive for future generations.

Finally, as the state begins its development and redevelopment plan, Mr. Kern continued, the county government will have a significant role playing in that process. As of last year, we restructured our planning board to be more of a high level planning board. This new group of volunteers will be in a perfect position to offset the mission for our county government.

In closing Mr. Kern thanked the county staff by saying while my colleagues and I set policies and direction, sometimes as clear as mud, the men and women working for our county make that vision happen. He then asked members of the county government who were present to stand and then asked the audience to give them a round of applause. He thanked everyone for their attendance today and he wished everyone a happy, healthy and prosperous new year.

Commissioner Director Kern assumed control of the meeting.
