First item was the vacancy report, nothing out of the ordinary, backfill of a few positions and a few hiring requests were submitted. He reported positions are being filled slowly. Second item, with summer vacations upon us, Mr. Lazorisak recommended canceling the second meeting of July and August.

COMMISSIONER COMMENTS

Ms. Ciesla reported she was able to attend the dedication of a portion of North Main Street in Phillipsburg for Sheriff McDonald. Ms. Ciesla, stated, "Mr. McDonald has been a part of this county from top to bottom. He grew up in Hackettstown, was a Police Officer and Chief in Washington

Township and lives in Phillipsburg." She mentioned that Brothers Before Others did a fantastic job with the ceremony. She encouraged everyone to go out and see signs.

Next, she provided an update regarding Broadband project. Ms.Ciesla has been on calls with NJIT talked about the FCC challenges. An email will be sent to the state requesting clarification regarding this challenge round. This round is for the non-profits and government entities to report all the issues. Unfortunately, we need people to submit their speed tests. Ms. Ciesla is remaining hopeful that all the previous challenges submitted have been accepted.

Lastly, Ms. Ciesla reminded everyone of the Bicentennial Summer Concert that will be held on Saturday, July 13, 2024, 4 p.m. to 8 p.m. at Bread Lock Park, 2627 Route 57, Stewartsville.

Mr. Sarnoski had nothing to report this evening.

Mr. Kern had a couple of items this evening. First item was regarding the Code Red Alerts. Code Red Alerts will be issued if the temperatures reach a certain level, cooling centers will need to be open. The state was discussing a mandatory pilot program; however, it is now a voluntary pilot program. Warren County is in the process of getting our homelessness numbers to see if this is something that the county would pursue. With state grants, the potential of grants monies would be far less than what the costs would be to the county. Mr. Kern mentioned the county will need to wait and see and monitor the situation.

Lastly, Mr. Kern spoke regarding the Delaware River Sojourn that had taken place last week. Public Information Director Art Charlton with our tourism has collaborated with them. Warren County had a small part of this event prior to Mr. Charlton's involvement, we now have three stops along the sojourn. Mr. Kern had the pleasure of speaking with some of the folks. He thanked Art for all of his work.

Janis Liepins, resident of Franklin Township came before the Board this evening with a question regarding concerns of property near the bridge on Asbury-Broadway Road. Request is to get the property cleaned up from the geese droppings. Mr. Kern recommended Mr. Liepins give the location after the meeting so the issue can be looked into.

Erin Andersen, resident of White Township and one of the owners of Buttzville Brewery. Ms. Andersen had two items for comment this evening. First item is in reference to the censoring the materials of what is going into the library. She is requesting the Commissioners to attend the Library Commission meeting on Thursday, June 27, at 5:30 p.m. Second item, the brewery is hosting an event on September 14, Protect the Butts bike ride, to support Colorectal Cancer Alliance. Trying to bring tourism to the county, all invited to attend. Ms. Andersen is also looking for promoters, sponsors and volunteers for the event.

Richard Crouse, owner of Down to Earth Farms, Harmony Township, first he thanked the Commissioners for all their help in preserving the farm in White Township that was slated for development. Second item he spoke about is Resolution #658-23, closure of Route 519 to vehicles

with a gross vehicle weight (GVW) over 13,000 tons. Mr. Crouse had additional questions for the Board that will be given after the meeting. He would like the Board and the enforcement of the police work together on how to resolve the issue with the local businesses.

Mr. Kern read into the record the paragraph from Resolution #658-23, for the public's information:

"WHEREAS, our county roads should not be used as a means for large commercial motor vehicle traffic to pass through Warren County, and to only allow CMVs over 13-ton gross vehicle weight ratings (GVWR) if they are engaged in transportation for local deliveries or local businesses in Warren County."

Mr. Kern continued this is the important part of the resolution that was sent to the State of New Jersey.

Tracy Smith, resident of Washington Township and Secretary to the Warren County Board of Agriculture, came before the Board to express her concerns with the weight limit restrictions and the affects it will have on our local farmers. Ms. Smith is hoping everyone will work together to keep our farmers in business.

Laura Winiarski, resident of Franklin Township, discussed her concerns of the truck traffic on County Route #632, Asbury-Broadway Road. Ms. Winiarski has gone before her local municipality, told not their issue due to it being a county road, also told the restrictions for the 102 is not enforceable in the State of New Jersey. Ms. Winiarski has reached out to the State of New Jersey to verify this is not enforceable, the state's reply this is not true. Ms. Winiarski would like to take the efforts of the police off the farmers being pulled over and get the police to pull over the trucks from Route 78 who are using the road at 70-75 miles per hour (MPH) before someone is killed.

Second item discussed by Ms. Winiarski, asking what the Board will do regarding the OPRA ban that Governor Murphy has signed. Residents cannot get information regarding the warehouse project.

Jacob Bilyk, resident of White Township, came before the Board to express his concerns with the weight limit restrictions on county roads.

Mr. Sarnoski commented on the length of time and process of this resolution. The resolution was not put in place in a short time period, this took years. The Board did not want this to hurt our local businesses.

Dale Crouse, resident of Harmony Township, ask the Board if an economic impact study had been conducted prior to the resolution restricting truck traffic being passed. Mr. Crouse is requesting an economic impact study be conducted even if it is after the fact. Secondly, Mr. Crouse suggested we define what this resolution is meant to do, to whom and when should tickets be issued. Mr. Crouse requested that the Board educate the involved law enforcement entities to alleviate sense of pulling over the local business traffic.

The Board responded to Mr. Crouse regarding his concerns. The definition of who is exempt would be a local business in Warren County. An impact study was done in 2020; identified 15 sites in Warren County where warehouse developments could take place, 8 of the sites are now under application. This study shown that our county roads would deteriorate. The Board clarified that no local businesses will be affected by this truck restriction resolution.

Mitchell Jones resident of Harmony Township came before the Board to discuss his concerns of the truck traffic restrictions. Mr. Jones understands this will be a learning curve and will take some time to get state police on board and get things straightened out. He brought to the Board's attention that a fertilizer supplier out of Bloomsbury, Hunterdon County, Growmark FS, the drivers will refuse loads to Warren County if they are going to be harassed. Ms. Ciesla asked how the drivers are being harassed. The driver got stopped per Mr. Jones. Mr. Jones continued this is poor for the agriculture community, could increase costs and be an issue.

Liza Thomas resident of Liberty Township responded to the first comment regarding the library. The library does not want to ban books. However, there is an issue with sexually explicit materials available to children. The books should be moved to the appropriate section of the library.

Mr. Sarnoski spoke on this matter about the proper access of this type of material.

Butch VanSeters resident of Harmony Township commended the Board for what they have done regarding the truck traffic on Route 519. Mr. VanSeters asked how many of the farmer's vehicles exceed the 13,000 tons. He expressed to the farmers of what it is like to live on the hill, the trucks jake-break down the hill 24/7. He is also concerned for the school buses stopping and traveling on County Route 519, that they are not hit by any of the trucks.

Nancy Mason resident of Belvidere expressed her concerns for the farmers trying to do business. The vehicles should have identification of the farm/business. The outside trucks should have a bill of lading. Ms. Mason recommended the police could go after the Amazon trucks stopping in the middle of the travel lane. Next, Ms. Mason spoke regarding awarded contracts, in particular the award of County Counsel who is based out of Easton, Pennsylvania and who is politically connected firm who is also in the business of developing warehouses. She asked, "If this would be a conflict of interest at some point?" She thanked the Board for all that they did in White Township. She reminded them there is a lot of farmland that goes up 519 into Blairstown.

Tom Bodolsky resident of Hope Township came before the Board with his understanding of what was spoke of this evening regarding the truck traffic. This is not only about business it is about quality of life. Mr. Bodolsky cautioned the Board if giving exemptions to local companies to deliver to Harmony Sand & Gravel, to fill the gravel pit in or gravel truck going through Hope, because it is a local business, going somewhere in Morris County. This is not an easy situation being asked of this Board. Mr. Bodolsky stated, this is the first time in decades he can sleep with his windows open. Mr. Bodolsky concurred with a previous comment regarding everyone sit down and define what is and is not restricted.

Charles Iulo resident of Hope Township echoed Mr. Bodolsky's comments; it has been night and day. This is a quality of life and a safety issue. Mr. Iulo thanked the Board for their efforts on this matter, hopes a resolution can be found on this matter.

Tim McDonough, resident Hope Township, came before the Board to discuss the truck traffic restrictions. Hope Township has signed on to work with the Commissioner Board to get the restrictions in place due to the safety issues. Mr. McDonough mentioned this resolution is not antifarming. As far as truck traffic coming through to local businesses, the truck driver will need to provide the bill of lading to the police. Mr. McDonough himself and on behalf of the residents of Hope Township, commended the Commissioners and County Administrator Alex Lazorisak for all the work that has been put into this resolution.

Terry Urfer, resident of Hope Township and on behalf of the residents of Hope, came before the Board to thank them for putting this resolution into place. He remarked there are truck restrictions all throughout the state. Mr. Urfer spoke of examples of local deliveries.

At this time, the Board has provided closing comments regard the truck traffic restrictions.

Ms. Ciesla state that based on our resolution local businesses and local deliveries should not be affected. Law enforcement had been told, if there is a need to reiterate this we will. When tickets are written, the officer will need to be able to defend the ticket, and this will not be able to be defended if it is a local business. The intention of the resolution is for through traffic for those are not doing business here. Ms. Ciesla stated we will revisit the stickers. The Board is here for our local businesses and local deliveries, not against.

Mr. Sarnoski mentioned this issue has been a part of his forefront for years. Multiple studies have been done over the years. The Commissioners have reworked this restriction, and we will look at all the aspects that help all the residents in Warren County. We will educate.

Ms. Ciesla added some of the issues we are seeing is the impact from warehouses in the surrounding areas.

Mr. Kern stated the Jaindl application was the lightning rod that made Warren County aware and engaged a group of constituents, like he has not seen before. It has worked its way over from Pennsylvania, encouraged anyone to see for themselves, go on Route 33 and see all the warehouses. Warren County is trying to prevent this from happening here. We want to preserve our roads. The traffic will destroy our roads. The Board is here on behalf of all of Warren County to find a solution to keep this county great and where we all want to live. There is a reason we all live here, it is the quality if life. The Board is committed to making this right working with the state and local police departments. In closing, the Board appreciates all for coming out this evening and showing a good level of decorum and participation.

Mr. Kern thanked Washington Township Police Department for providing security, as well as the Mayor and Councilmembers of Washington Borough for having the Commissioners this evening.


